- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 5. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.
- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

4. Forms of EMD and PBG

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. A. MINIMUM QUALIFICATION CRITERIA

- 1. The bidder firm should meet following eligibility criteria to qualify:
- (a) **For MSE / Start-up Firm: Capability Equipment & Manufacturing Facilities**: The bidde r firm should have capability to manufacture and supply of tendered item.
- (b) **For Other firm Experience and past performance:** The bidder firm may be Manufacturer / Proven Supplier / Authorized dealer or distributor of tendered item or bidder may participate with manufacturing authorization form (issued by manufacturer of tendered item).

Material Description: LDPE Film Roll 350 MM

Total 400 Rolls of 10 Kg each Roll i.e Total quantity in weight 4000 Kgs Excluding weight of core.

- 1. Width: Double folded 350 mm (total width 700 mm)
- 2. Thickness: 60 micron (± 10 micron)
- 3. Transparency: More than 80 %
- 4. Weight of Roll: 10 Kgs (± 200 gms) (excluding weight of core)
- 5. Outer Core Dimension: 10.5 cms \pm 0.5 cms including core width
- 6. Perforation (in 10 sq. cm): 60 to 70 nos.
- 7. Temperature on shrink: Maximum 300°C. To be sustained during the packing Wrap Machine.
- 8. The core should be strong enough to sustain 10 Kg. Load and should not shrink/ Collapse durin g Transportation.
- 9. The Roll of the film should be printed with India Security Press, Nashik Road having letter height of 15mm and logo of dimension 15X15mm at a gap of every 50 mm width of film.
- 10. Test Certificate of the film confirming above parameters to be provided by the Supplier along with each supply.
- 11. Note: Strictly to follow the Notification -2018 issued by Environment Department, Maharashtra Pollution Control Board vide. No. Plastic-2018/C.R.No.24/TC-4. Confirm notice application and certificate along with quotation may be submitted regarding otherwise their quotation will not be considered.

C. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement:-

(To be submitted on firm's Letter Head as a token of acceptance)

- 1) Pre-Dispatch Sample:- A Sample of 1 Roll (at least of 10 Kg) of Double Folded LDPE Shrink Wrap Film 350 MM is to be supplied free of cost, within 15 days from the date of issue of Suppl y Order/GeM Contract for approval. Sample suitability will be conveyed to the supplier within 1 5 days from the date of receipt of Sample. Bulk supply shall be start after receipt of sample suitability.
 - 2) Delivery Schedule:- Delivery Schedule:- After acceptance of Sample.
 - 1 MT (100 Rolls) within 60 days from the date of issue of Supply Order/GeM Contract.
 - ii. 1 MT (100 Rolls) within 120 days from the date of issue of Supply Order/GeM Contract.
 - iii. 1 MT (100 Rolls) within 180 days from the date of issue of Supply Order/GeM Contract.
 - iv. 1 MT (100 Rolls) within 240 days from the date of issue of Supply Order/GeM Contract.
 - 3) Quality Control Requirement:-
- (i) The material supplied by the successful bidder will be accepted on all parameters as per specification p rovided in the Bid Document. The purchaser reserves the right to get the material supplied tested from inhouse laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.
 - (ii) After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is n oticed then the same will be replaced free of cost by the supplier/seller up to India Security Pre ss, Nashik Road, failing which equivalent amount of defective material will be deducted in the

subsequent bills or from any amount due to them.

D. Special Conditions of Contract (SCC)

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price b id of the item to be procured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis the refore the cost of the insurance will also the part of the cost of the material borne by the suppli er. A specific insurance cover for each consignment/supply is to be given by firm, as applicable
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier sh all send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to c lear or receive (as the case may be) the goods in terms of the contract.
- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies e tc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include tax es and duties as per law of the land in the tender, no claim thereof will be considered by purch aser at a later stage.

5) NOTE:

- 1. All experience, past performance and capacity/ capability related/ data should be certified by the authorized signatory of the bidder firm.
- 2. Decision on Finalization of tender will be taken based on the documents submitte d along with the tender. All documents must be submitted as per tender requirement failing which offers will be liable for rejection.
- 3. All the pages submitted are to be sealed & signed by Authorised Signatory failing which tender shall be treated as unresponsive.
