### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific ATC

#### Qualification/ Eligibility Criteria

**I) For MSE/Start-up firm:** - The bidder must have capability to provide the relevant services.

**II) Experience and past performance:** The bidder should have experience of having successfully completed similar kind of services for the value at least Rs.2.06 Lakh in any one of the last five years ending on '31.03.2023'.

**Note:** Participating bidder needs to submit all related documents along with the bid.

**V) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
