1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 4. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. Minimum Qualification Criteria:

1. The bidder firm should meet following eligibility criteria to qualify:

(a) For MSE / Start-up Firm: Capability – Equipment & Manufacturing Facilities: The bidder firm should have capability to manufacture and supply of tendered item.

(b) For Other firm – Experience and past performance: The bidder firm may be Manufacturer / Prove n Supplier / Authorized dealer or distributor of tendered item or bidder may participate with manufacturing authorization form (issued by manufacturer of tendered item).

Note: Participating bidder needs to submit all related documents along with the bid.

2. Applicability in Special Cases:

a) For Existing successful Past Suppliers: In case the bidder who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of re quirements above, would also be considered to be qualified in view of their proven credentials, for the max imum quantity supplied by him in such recent past. (This clause is not applicable for Security items as notif ied

b) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Fin ancial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such owners

hip.

c) **Start-up Enterprises**: Requirements of prior experience and turnover would be relaxed for Start -up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

3. **Certificate of MSE**: The firm must have a valid registration certificate as MSE issued by NSIC, D GS &D or any authorized body by Ministry of MSME for Manufacturing of the tendered item and the same s hall be submitted by the firm along with tender/bid.

4. The Bidder shall give following undertakings on their Letter Head regarding this requirement.

i) The firm should give a declaration that, "We <Name of the firm> have not been black-listed/debarred for dealing by Government of India/PSU/Reputed Organization in the Past."

ii) Agree to withdraw all deviations: The declaration that "We <Name of the firm> agree to withdraw all th e deviations, if any, unconditionally and accept all the terms and conditions of t he tender document includ ing the technical specifications".

2. TECHNICAL PARAMETERS: The Technical Parameters shall be as under:

* Dimensions should match to the drawing to be provided to the successful bidder.

C. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement

(To be submitted on firm's Letter Head as a token of acceptance):-

1) Pre-Dispatch Sample:- Two (02) Nos. of sample boxes as a Pre-Production to be supplied within 15 days from the date of issue of Supply Order/GeM Contract at free of cost. Sample suitability will be conveyed wi thin 15 days from the date of receipt of sample.

2) Delivery Schedule:- Bulk Supply: After sample suitability, the delivery schedule will be as under.

- i) 2000 no. of Boxes within 60 days from the date of issue of Supply order GeM contract.
- ii) 2000 no. of Boxes within 90 days from the date of issue of Supply order GeM contract
- iii) 2000 no. of Boxes within 120 days from the date of issue of Supply order GeM contract
- iv) 2000 no. of Boxes within 150 days from the date of issue of Supply order GeM contract

However, ISP can vary the delivery quantity by +/- 30% by informing the firm in advance.

3) Each of the above delivery shall be proportionally placed as per parallel contract/bid splitting condition.

4) Quality Control Requirement:-

(i) The material supplied by the successful bidder will be accepted on all parameters as per specification p rovided in the Bid Document. The purchaser reserves the right to get the material supplied tested from inhouse laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwis e the purchase of the stores at the risk and cost of the contractor.

(ii) After receipt of goods, the goods will be inspected /tested at ISP. If any defect/variation is noticed then the same will be replaced free of cost by the supplier/seller up to India Security Press, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amoun t due to them.

D. Special Condition of Contract (SCC):

1) **Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be pro cured.

2) Insurance: Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore the c ost of the insurance will also the part of the cost of the material borne by the supplier. A specific insurance cover for each consignment/supply is to be given by firm, as applicable.

3) **Distribution of Dispatch Documents for Clearance/Receipt of Goods** The supplier shall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.

4) **Taxes and Duties**: Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incur red until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

5) **Terms and Mode of Payment**: 100% payment will be released within ten (10) days of issue of consig nee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done th rough online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Ban k, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.

6) **Bid Splitting/Parallel Contract**: India Security Press, Nashik reserves its rights to conclude Bid Splitti ng/Parallel Contract with more than one bidder (maximum upto two bidders for the same tender) without a ny prejudice to the capacity of the L1 bidder. In case of splitting in two, the ratio of 70:30 will be used.

7) **Termination/Short Close of Contract**: India Security Press, Nashik reserves the right to terminate th e contract, in whole or in part for ISP's convenience, by serving written notice on the supplier at an y time during the currency of contract.

8) **NOTE**: i. All experience, past performance and capacity/ capability related/ data should be certified by t he authorized signatory of the bidder firm.

ii. Decision on Finalization of tender will be taken based on the documents submitted along with the tender . All documents must be submitted as per tender requirement failing which offers will be liable for rejectio n. iv. All the pages submitted are to be sealed & signed by Authorized Signatory failing which tender s hall be treated as unresponsive.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
