1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up

to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text-based ATC clauses

A. Minimum Qualification Criteria:

- 1. The bidder firm should meet following eligibility criteria to qualify:
- (a) For MSE / Start-up Firm: Capability Equipment & Manufacturing Facilities: The bidder firm sh ould have capability to manufacture or supply of tendered item.
- (b) **For Other firm Experience and past performance:** The bidder firm may be Manufacturer / Prove n Supplier / Authorized dealer or distributor of tendered item or bidder may participate with manufacturing authorization form (issued by manufacturer of tendered item).

Note: Participating bidder needs to submit all related documents along with the bid.

2. Applicability in Special Cases:

- a) **For Existing successful Past Suppliers**: In case the bidder who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security items as notified.
- b) **Joint Ventures and Holding Companies**: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial St anding Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- c) **Start-up Enterprises**: Requirements of prior experience and turnover would be relaxed for Start -up en terprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.
- 3. The Bidder shall give following undertakings on their Letter Head regarding this requirement.
- i) The firm should give a declaration that, "We have not been black-listed/debarred for dealing by Governm ent of India/PSU/Reputed Organization in the Past."
- ii) Agree to withdraw all deviations: The declaration that "We agree to withdraw all the deviations, if any, u nconditionally and accept all the terms and conditions of the tender document including the technical specifications".

4. Quality Control Requirement: -

- (i) Material will be accepted on the basis of performance & test report submitted by the firm from any NAB L/Government approved Lab complying all parameters mentioned in ISP specification. The purchaser reser ves the right to get the material supplied tested from inhouse laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.
- (ii) If any defect / variation is noticed then the same will be replaced free of cost by the supplier /seller up t o India Security Press, Nashik Road , falling which equivalent amount of defective material will be deducte d in the subsequent bills or from any amount due to them

5. Special Condition of Contract (SCC):

i) **Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.

- ii) **Insurance**: Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore the cost of the insurance will also the part of the cost of the material borne by the supplier. A specific insurance cover for each consignment/supply is to be given by firm, as applicable.
- iii) **Distribution of Dispatch Documents for Clearance/Receipt of Goods** The supplier shall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.
- iv) **Taxes and Duties**: Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incur red until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.
- v) **Terms and Mode of Payment**: 100% payment will be released within ten (10) days of issue of consign ee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done thr ough online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.
- vi) **Termination/Short Close of Contract** India Security Press, Nashik reserves the right to terminate the contract, in whole or in part for ISP's convenience, by serving written notice on the supplier at an y time during the currency of contract.

6. **NOTE**:

- i. All experience, past performance and capacity/ capability related/ data should be certified by the authori zed signatory of the bidder firm.
- ii. Decision on Finalization of tender will be taken based on the documents submitted along with the tender . All documents must be submitted as per tender requirement failing which offers will be liable for rejection
- iii. All the pages submitted are to be sealed & signed by Authorized Signatory failing which tender shall be treated as unresponsive.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
