- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. - 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is

validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. QUALIFICATION/ ELIGIBILITY CRITERIA

**Experience and past performance: The experience and Past performance Criteria is exempt ed.

(a) Capability, equipment and manufacturing facilities:

- (i) The bidder must have an annual capacity to manufacture and supply at least 25288 sq. met er of similar type of Cotton Fabric based Cover Material.
- (b) The bidder firm shall provide the following details with the bid documents :
 - (i) Name of the machine(s) utilized to supply the quoted product.
 - (ii) The number of machines being utilized for the production and the capacity of each machine
 - (iii) Total Annual Capacity of the Machine.
 - (iv) Supply orders in hand and proportionate capacity to supply the quoted product.

Note:

- (i) At the discretion of the purchaser, the capacity/ capability Assessment/ Verification of bidder/ manufacturer firm(s) might be undertaken by Committee or through a third party Technical Cons ultancy/ Inspection agencies to ensure that the firm is/ are identified and capable to develop and supply the item/material/product as required. The capacity and capability may be verified (if nece ssary) by ISP as per the format of Capacity and Capability Assessment Form placed at Annexure-III of the Tender document. Capacity and capability Assessment form shall be signed by capacity verification Team and Bidders authorized representative for record purpose, the committee may take photographs during capacity verification at the Bidders Premises.
- (ii) During the capacity / capability assessment, the firm have to manufacture the Cotton Fabric

Based Passport Cover Material meeting the ISP tender specification in presence of the committee nominated by ISP. The samples produced in presence of committee shall be taken by committee for machine trial at ISP and capability assessment shall be finalized based on Lab test and machine trial.

(iii) All the Capacity/capability related data must be certified by the authorized signatory of the bidder firm.

(c) Financial standing:

- (i) The average annual financial turnover of the bidder firm (manufacturer or principal of author ized dealer) during the last three years (i.e. 2020-2021, 2021-2022 and 2022-2023) ending on 3 1st March 2023 should be at least 1,27,68,000 as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant /Cost Accountant
- (ii) The net worth of the bidder should:
- a) not be negative on 31st March 2023 and
- b) should not have eroded by more than 30% in the last three years, ending 31st March 2023.

Note: -

i) To ascertain this criteria the net worth of initial and last financial year shall be compared. ii) For MSEs and Start-ups (registered for the tendered item) all financial criteria shall be exempted. However, capacity and capability of the firm may be verified.

iii) All the financial data has to be duly certified by certified accountants e.g. Chartered Account ants (CA). The bidder has to submit a copies of audited financial documents (Balance sheets, Pr ofit & Loss account statement, etc), or Audited Annual reports in support of clause no. 1(c) abov e.

2. Undertaking(s):

- (i) The firm should give undertaking that, "We M/s. < Name of the firm > have not been b lacklisted by Government of India in the past".
- (ii) The firm should give undertaking that, "We M/s. <Name of the firm> agree to withdr aw all the deviations, if any, unconditionally and accept all the Terms and conditions of the document including the technical specifications."
- (iii) The firm should give undertaking that, "We M/s. <Name of the firm> have read and a ccept all the terms & conditions of GIT & GCC of the Bid document".
- (iv) The firm should give undertaking "that the Operation carried in Pakistan/China, if a ny, should be suitably firewalled from the contract/ operations with Government of I ndia. Further, no employee who has previously worked or been posted in Pakistan C hina, and no Pakistani/ Chinese national or person of Pakistan/ Chinese origin should be engaged by the company for this project".

3. Applicability in special cases:

3.1 Applicability to 'Make in India': Bidders (manufacturer or principal of authorised represent ative) If the product is being manufactured in India under a license from a foreign manufactur er who holds intellectual property rights and where there is a technology collaboration agreem ent/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would als o be considered to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. Iii) the bidder (manufacturer or principal of authorised representative) furnish es along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.

- **3.2 Authorized Representatives:** Bids of bidders quoting as authorised representative of a pri ncipal manufacturer would also be considered to be qualified, provided: i) their principal manu facturer meets all the criteria above without exemption, and ii) the principal manufacturer fur nishes a legally enforceable tender-specific authorisation in the prescribed form assuring full g uarantee and warranty obligations as per the general and special conditions of contract for sa me or similar 'Product' for past three years ending on 31.03.2023.
- **3.3 Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures canno t (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipm ent, and each partner must comply with all the PQC criteria independently. However, for the p urpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Hol ding Company can be clubbed with only one of the fully owned subsidiary bidding company, w ith appropriate legal documents proving such ownership.
- **3.4 Start-up Enterprises :** Requirements of prior experience and turnover would be relaxed for S tart-up enterprises as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

4. Other Eligibility requirements for the Bidders:

- **4.1** The bidder shall submit Local Content details as per clause No. 9; Verification of Local content, of Public procurement (Preference to make in India) order 2017 No. P-45021/2/2017-PP(BE-II); it is re quested to provide a certificate from statutory auditor or cost auditor of your company.
- **4.2** The bidder has to submit **Power of Attorney/ Authorization** indicating that authorized signa tory is competent and legally authorized to submit the tender and / or enter into legally binding cont ract on firm's letter head. Also provide two contact numbers, email ld.

4.3 Manufacturer's Authorisation Letter:

- **a)** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /C ertificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id a nd Phone No. required to be furnished along with the bid.
- **b)** The bidder shall submit the manufacturer's authorization letter to this effect as per the standard f orm provided in buyer uploaded ATC Uploaded document.
- **c)** One manufacturer can participate through one authorized agent or one agent can participate on behalf of one Principal Manufacturer only.
- **4.4** The application should be submitted in English Language. The authenticated copies of the documents in support of the applicant's claims must be submitted in **English language**.
- **4.5** Decision on Finalization of tender will be taken based on the documents submitted along with th e tender. All documents must be submitted as per tender requirement failing which offers will be lia ble for rejection and no further correspondence will be made/ entertained for clarification after opening of the tender.
- **4.6** All the pages submitted are to be required & sealed by Authorised Signatory failing which tende r shall be treated as unresponsive.
- **4.7** Bidder firm shall submit the copy of PAN & GST Registration Certificate.

5. Bid Splitting/Parallel contracts:

India Security Press, Nashik reserves its right to conclude Bid Splitting/Parallel Contract with more than one bidder (maximum upto two bidders for the same tender) without any prejudice to the capacity of the L1 bidder, as given below:

6. General Condition Of Contract (GCC):

- **6.1 : Pre-bid Conference:** The pre-bid conference will be held on 03.07.2024 at 11.00 hrs. IST. - **6.2 Packing and Marking**: As per Technical Specifications of the tender document.
- **6.3 Transportation of Goods:** The transportation of goods to be procured will be done by the sup plier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.
- **6.4 Inspection and Quality Control** In addition to clause No. 9 of GCC the following shall also be applicable:-
- i) The material supplied by the successful bidder will be accepted on manufacturer's conforming to all parameters as per specification as stated in Technical Specification. The material will be accepte d on manufacturers guarantee certificate to be sent to purchaser. If any defects observed or the material is found unsuitable, then the same will be returned to the supplier for free replacement upto In dia Security Press, Nashik or the purchaser shall be entitled to cancel the contract, and if so desired, purchase or authorize purchase of the stores at the risk and cost of the contractor.
- **ii) Pre-despatch Inspection**: At the discretion of the Chairman and Managing Director, Security Pri nting and Minting Corporation of India Limited or The Chief General Manager, India Security Press, N asik, Maharashtra, authorized official(s) will carry out Pre-dispatch inspection at manufacture's site. All expenses towards the travel, boarding, lodging, miscellaneous expenditure and daily allowance allowances shall be borne by the purchaser .in the event that the purchaser is not able to depute its representative; it shall issue specific authorization to the supplier to dispatch the said Cotton Fabric Based Passport Cover Material (Buckram) size 580 X 545 mm with waiver certificate.
- **iii)** The inspection procedure and the arrangement will be according to the contract agreed mutually between the supplier and the purchaser.

6.5 Pre-Production Sample:

- (a) The successful bidder(s) shall supply 1000 Nos. of Cotton Fabric Based Passport Cover Mat erial as a pre-production sample. The bulk supply shall be supplied after suitability of Pre-production sample.
- **(b)** In case, the pre-production sample does not come upto the contract requirement, sufficien t chances will be given to the successful firm(s) to improvements, in a transparent and equitable man ner. However, such chances will be given with a reasonable time frame & it shall not be open ended.
- (c) The reasons of failure of sample of one bidder may be shared with all bidders while hiding the identity (without violating any Intellectual Property Rights (IPR) involved) of the Bidder of failed sa mple. In case the supplier fails to supply the materials as per the tendered specification within the reasonable time-frame as decided by the unit, the contract may be cancelled. Rejected sample shall n ot be returned.
- **6.6 Insurance:** A specific insurance cover for each consignment / supply is to be given by the firm, a s applicable.
- **6.7 Warranty Clause:** Supplier should submit Test Certificate and provide the warranty with free re placement for a period of 12 months from the date of acceptance of Material at ISP.
- **6.8 Taxes and Duties**: If the tenderer fails to include taxes and duties as per law of the land in the t ender, no claim thereof will be considered by purchaser at a later stage.
- **6.9 Terms and Mode of Payment:** Payment will be released within ten (10) days of issue of Consi

gnee Receipt-cum Acceptance Certificate (CRAC) and submission of bills.

- **6.10 Liquidated Damages:** Being a Development Tender, the Liquidated Damages clause is not app licable. However, the successful firm(s) shall supply the material as per delivery schedule given the T ender/ Purchase Order(s).
- 6.11 India Security Press, Nashik reserves the right to terminate the contract, in whole or in part for ISP's convenience, by serving written notice on the supplier at any time during the currency of contract.
- 6.12 If there is any change in policy of Government of India, Purchaser reserves the right to foreclose the order placed at any point of time with a written notice of one month in ad vance.
