Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 5. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

- **I)** For MSE/Start-up firm: Capability Equipment & Manufacturing Facilities: The bidder firm sh ould have capability to Supply, Install, Test and Commission of PDB Panel, XLPE PVC Cables and GI Earthing, Jointing Kits, galvanized cable tray, Electrical insulation mat,.
- **II) For other firm Experience and past performance:** The bidder firm may be Manufacturer/ Proven supplier/Authorized dealer or distributor of PDB Panel, XLPE PVC Cables and GI Earthing, Jo inting Kits, galvanized cable tray, Electrical insulation mat or bidder may participate with manufact uring authorization form (issued by manufacturer of tendered item).

Note:

- i. Participating bidder needs to submit all related documents along with the bid. In case, t he bidder is a Manufacturer/Proven supplier/Authorized dealer or distributor of the offer ed material, bidder has to submit relevant documents for the same. In case, the bidder is not a Manufacturer/Proven supplier/Authorized dealer or distributor of the offered ma terial, then bidder has to submit the Manufacturing Authorization Form (issued by Manufacturer of tendered item). The bidder shall submit the manufacturer's authorization le tter to this effect as per the standard form provided in "buyer uploaded ATC Uploaded docume nt".
- **III) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of au thorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **IV) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.
- **V) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

VI) Undertaking:-

a) The bidder has to provide the undertaking that "We M/s. <Name of the firm> have

not been blacklisted by Government of India in the past".

b) The bidder has to provide the undertaking that "We M/s. <Name of the firm> agre e to withdraw all the deviations, if any, unconditionally and accept all the Ter ms and conditions of the document including the technical specifications."

VII) Delivery Schedule:-

- 1.Firm should deliver the MV PDB panel and other material as per Technical Specifications within 60 days after placement of GeM Contract.
- 2. Firm should complete the ITC work and other allied works within 30 days after the receip t and acceptance of the materials in ISP store.
- **IX) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The paym ent will be done through online mode only. Therefore, the suppliers have to produce all the Bank d etails such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender docume nt. TDS, if any, will be deducted as applicable.
- **X) Warranty: -** Firm should provide 1-year free replacement warranty.
- **XI) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditi ons aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of d elayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- XII) Ministry of Finance, Department of Expenditure, Public Procurement Division, Orde rs (Public Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23 rd/ 24th July 2020 (or a ny further amendments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. Bidders are required submit the appropriate undertaking in this regard. Salient features of this are:

- (2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more t han fifteen percent of Capital or profits of the partnership.
- (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the r elevant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the auth or of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and a ny other natural person exercising ultimate effective control over the trust through a chain of cont rol or ownership
- (vi)An Agent is a person employed to do any act for another, or to represent another in dealings w ith third person.
