OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

# C. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement (To be su bmitted on firm's Letter Head as a token of acceptance):-

- 1) Pre-Dispatch Sample:- A Sample of 2 Sets of RSC Type Corrugated Fiber Board Boxes (VS -1, VS-2, VS-3) is to be submitted free of cost for 5 / 8 approval , before bulk Supply. Sample m ust be submitted within 10 days from the date of issue of Supply Order/GeM Contract. Sample suitability will be conveyed to the supplier within 07 days from the date of receipt of sample.
- **2) Delivery Schedule:** Quarterly supply (1500 Sets per quarter X 4 Lot= 6000 sets of RSC T ype(VS-1, VS-2, VS-3). First lot shall be supplied within 47 days from the date of issue of GeM C ontract/Supply Order.

### 3) Quality Control Requirement:-

- (i) The material supplied by the successful bidder will be accepted on all parameters as per spe cification provided in the Bid Document. The purchaser reserves the right to get the material s upplied tested from in-hous laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or other wise the purchase of the stores at the risk and cost of the contractor.
- (ii) After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is n oticed then the same will be replaced free of cost by the supplier/seller up to India Security Pre ss, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

### **D. Special Conditions of Contract (SCC):**

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price b id of the item to be procured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis the refore the cost of the insurance will also the part of the cost of the material borne by the suppli er. A specific insurance cover for each consignment/supply is to be given by firm, as applicable
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier sh all send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to c lear or receive (as the case may be) the goods in terms of the contract.

- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies e tc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include tax es and duties as per law of the land in the tender, no claim thereof will be considered by purch aser at a later stage.
- **5) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of iss ue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all t he Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Te nder document. TDS, if any, will be deducted as applicable.
- **6) Bid Splitting/Parallel Contract:** India Security Press, Nashik reserves its rights to conclud e Bid Splitting/Parallel Contract with more than one bidder (maximum upto Three bidders for t he same tender) without any prejudice to the capacity of of the L1 bidder. In case of splitting i n three, the ratio of 70:30 will be used.

### Note:-

- i. All experience, past performance and capacity/ capability related/ data should be certified by the authorized signatory of the bidder firm.
- **iii.** Decision on Finalization of tender will be taken based on the documents submitted along with the tender. All documents must be submitted as per tender requirement failing which offers will be liable for rejection.
- **iv.** All the pages submitted are to be sealed & signed by Authorised Signato ry failing which tender shall be treated as unresponsive.
- **(VI) Quantum of LD:-**If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buy er will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered un der Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever
- **(VII) Payment Terms: -** Payment will be released within ten (10) days of issue of Consignee Receipt-cum Acceptance Certificate (CRAC) and submission of bills.
- (VIII) Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23rd/24th July 2020 (or any further amendments thereof) regarding eligibility of bidders from spe cified countries shall be applicable to this tender. Bidders are required submit the appropriate undertaking in this regard. Salient features of this are:

- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.
