1. In addition to General Terms and Conditions of GeM, the following Special T&C shall be applicable for Online UPS (Version 2.0) with reference to Installation and Commissioning.

Seller's Responsibility: Installation and Commissioning shall involve all the interconnections, any cabling between power source, switch boards within 3 metre range for input power and connecting Output power in the Scope of seller.

Buyer's Responsibility: Buyer will ensure well ventilated/covered site/room having requisite power points/distribution board to provide input power to UPS as well as to take out power from UPS within 3 metre of the location of UPS placement.

The above is not applicable for the stores supplied without installation and commisioning.

Note: The above is indicative and any incidental requirement related to above responsibilities shall also be considered in the responsibilities of Buyer/Seller as applicable.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

NOTE: The Technical Specification and Scope of work enclosed with bid documents (Attached in Buyer Added Bid Specific ATC) will supersede all the parameters selected. Accordingly, before qu oting bidders are requested to go through enclosed Technical Specification and Scope of work an d bid accordingly.

- **III) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized re presentative) who is a successful past supplier of 'The Product' in at least one of the recent past three procur ements, who do not meet any or more of requirements above, would also be considered to be qualified in vie w of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is n ot applicable for Security Items as notified by Government of India from time to time.)
- **IV) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat c annot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner mu st comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **V) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.

- **XI) Payment Terms:** Payment will be released within ten (10) days of issue of Consignee Receipt-cum Acc eptance Certificate (CRAC) and submission of bills.
- **XII) Warranty: -** Warranty period of the UPS shall be as mentioned in the technical specification & scope of work (Clause 3-m).

XIII) Note regarding MSE and MII purchase preference:

Instant bid is non-splitable / non-dividable in nature. Therefore, in case L1 is non-MSE then MSE firm quoting price within L1+15% band will be awarded full tendered quantity subject to matching the L1 prices.
