- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. - 8. - (1) Transportation of Domestic Goods: The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should also be indicated in the price bid of the item to be procured
- (2) Insurance: A specific insurance cover for each consignment / supply is to be given by the firm, as appl icable.

II. Quality Control Requirements:

The material supplied by the successful bidder will be accepted on the basis of trial carried out on the mac hine, and other technical requirement mentioned in Technical Specifications along with guarantee/ warrant y certificate to be sent to purchaser along with each consignment. If any defects observed or the material found unsuitable, then the same will be returned to the supplier for free replacement up to India Security P ress, Nashik.

III. Qualification/ Eligibility Criteria:

1. The bidder firm should meet the following eligibility criteria to qualify in the Techno Co mmercial Bid:-

- **b)** Capability-Equipment and manufacturing facilities: The bidder must have an annual capacity to supply and installed at least 01 No. "DOD UV curable bulk inking piezo inkjet head with controller".
- **c) Financial Standing:** The average annual financial turnover of the bidder during the last three years, ending on 31.03.2024, should be at least Rs. 43,42,400/- on 31.03.2024 as per the annual report (audited balance sheet and profit and loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India.
- i. The net worth of the Bidder should not be negative on 31.03.2024 and also
- ii. should not have eroded by more than 30% in the last three years, ending on 31.03.2024.
- Note 1. To ascertain this criteria net worth of initial and last financial year should be compared.
- Note 2: For MSEs and Start-Ups (registered for the tendered item) all financial criteria shall be exempted. However, its capacity and capability may be verified (if necessary) by the respective unit.

2. Applicability in Special cases:

- (i) Applicability to 'Make in India': Applicability to 'Make in India": Bidders (manufacturers or princip al of authorised representative) if the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreem ent/ transfer of technology agreement for indigenous manufacturer of a product developed abroad with cle ar phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provid ed: i) their foreign manufacturer who hold intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreem ent/ transfer of technology agreement for indigenous manufacture of a product developed abroad with cle ar phased increase in local content. Ii) the bidder (manufacturer or principal of authorised representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and perfor mance of 'The Product' offered including all warranty obligations as per the general and special conditions o contract.
- (ii) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the

criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender -specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the g eneral and special conditions of contract for same or similar product for the past three years ending on 31. 03.2024.

- (iii) For Existing Successful Past Suppliers: In case the bidder (Manufacturer or Principal of authorised rep resentative) who is a successful past supplier of 'The Product' in at least one of the recent past three proc urements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more or requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL.
- (iv) Joint Ventures and Holding Companies: Credentials of the Partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/ Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- (v) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for start-up e nterprises as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), subject to the ir meeting the quality and technical specifications. Such Start-ups may be either MSE or otherwise.

3. Undertaking:

(i) Any bidder from a country which shares a land border with India (excluding countries as listed in the we bsite of Ministry of External Affairs, to which the Government of India has extended lines of credit or in whi ch the Government of India is engaged in development projects) will be eligible to bid in this tender only if the bidder is registered with the Registration Committee constituted by the Department for promotion of In dustry and Internal Trade (DPIIT). The bidders shall enclose following certificate in this regard.

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; and solemnly certify that we are not from such a country or, if from such a country, we are registered with the Competent Authority (copy enclosed). We hereby certify that we fulfill all requir ements in this regard and are eligible to be considered."

(ii) In tenders for Turnkey contracts including works contracts, the successful bidder shall not be allowed t o sub-contract works to any contractor from a country which shares a land border with India unless such c ontractor is similarly registered with the Registration Committee constituted by the Department for Promot ion of Industry and Internal Trade (DPIIT). In such cases the bidders shall enclose following certificate:

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India and on sub-contracting to contractors from such countries,; and solemnly certify that we are not from such a country or, if from such a country, we are registered with Competent Authority (c opy enclosed) and we will not subcontract any work to a contractor from such countries unless such contractor is registered with the Competent Authority. We hereby certify that we fulfill all requirements in this regards and are eligible to be considered."

(iii) "Bidder" including the terms 'tenderer', 'consultant' or 'service provider' in certain contexts) means an y person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descripti ons of bidders stated hereinbefore, including any agency branch or office controlled by such person, partic ipating in a procurement process.

- (iv) "Bidder from a country which shares a land border with India" for the purpose of this Order means:-
- a) An entity incorporated, established or registered in such a country; or
- b) A subsidiary of an entity incorporated, established or registered in such a country; or
- c) An entity substantially controlled through entities incorporated, established or registered in such a country; or
- d) An entity whose beneficial owner is situated in such a country; or
- e) An Indian (or other) agent of such an entity; or
- f) A natural person who is a citizen of such a country; or
- g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
- (v) The beneficial owner for the purpose of (III) above will be as under:
- a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more judicial person, has a controlling ownership inter est or who exercise control through other means.
- b) Explanation:
- (1) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.
- (2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen perce nt of Capital or profits of the partnership.
- (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural pers on(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals:
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- (vi) An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
