- 1. - 6. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

- **I)** For MSE/Start-up firm: Capability Equipment & Manufacturing Facilities: The bidder firm sh ould have capability to supply the services as per tender document.
- **II) For other firm Experience and past performance:** The bidder should have experience of having successfully supplied truck hiring services of Rs 2,07,000/- in any one of the last five years ending on '31.03.2024.'

III) For Existing successful Past Suppliers: In case the bidder who is a successful past supplie

**IV) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.

**V) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

# VI) Undertaking:-

- The bidder has to provide the undertaking that "We M/s. <Name of the firm> have not been blacklisted/debarred by Government of India/PSU/ Any reputed organization in the past"

**VIII) Contract Period-** Contract shall commence from the date mentioned in GeM Contract/Purch ase Order for a period of One (01) Year. Vehicles shall be provided without driver and without fuel on monthly 24 X 7 basis.
