If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 4. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

- (I) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.

Application :- To grind a wide range of food items such as Wet rice, green & red chillies, coco nut, potatoes, urad dal, tomatoes, ground nut, spices, onion, carrot, garlic, ginger, green veget ables, prepare smooth gravies and all type of pest/ pulp.

Operation :- Machine should have flow of food material from the top feeding hopper. Rotor should rotate in anticlockwise direction. The beaters pass just beneath the ratchet teeth liner fitt ed the top half of the crushing chamber/ grinding chamber. There should be gap of 3mm betw een the liner teeth & the tips of the rotating beaters. This cuts the material caught between liner teeth like a sword with a scissors action at approx. 2800 rpm. After the required size reduction of food material, the food particles should pass through the S.S. metal screen fitted inside the lower discharge end of the grinding chamber. No sieving should be required as the approximate size of S.S. metal screen fitted will not allow coarser material to pass through.

The gravy machine should have User friendly design, semi-automatic operation, easy to clean and maintain ensuring hygiene and convenience. Should have sleek and compact design so the

at gravy machine seamlessly fits into less space in kitchen area.

Terms and Condition:-

- 1. Firm should offer the Gravy machine exactly as per our requirement.
- 2. Firm should quote the rate inclusive of all taxes, duties, transportation charges.
- 3. Firm should offer one year warranty for the offered Gravy machine.
- 4. Firm should clearly mention detail features, working principle & operation, in support with c oloured pictures/images of offered gravy machine while submitting the quotation for evalu ation purpose.
- 5. Offer of the firm not fulfilling our technical specifications will be rejected.
- (V) Delivery Schedule: Within 60 days from the date of issue of Contract.
- (VI) Warranty: -Warranty for the period of 01 (One) Year.
- **(VII) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Ser vices within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be e ntitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force M ajeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- **(VIII) Payment Terms:** Payment will be released within ten (10) days of issue of Consignee Receipt-cum Acceptance Certificate (CRAC) and submission of bills.
- **(IX) Anti-Bribery Management System (ABMS):** By participating in this tender, the suppli ers/Vendors/ Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to V igilance.
