### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

**NOTE: The Technical Specification mentioned in bid (Additional Specification Parameters) will supersede all the parameters selected. Accordingly, before quoting bidders are requested to go through Additional Specification Parameters of the bid accordingly.**

#### Buyer Added Bid Specific ATC

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

**I) For MSE/Start-up firm: Capability - Equipment & Manufacturing Facilities:** The bidder firm should have capability supply of similar kind of MS office License as per attached technical specifications.

**II) For other firm - Experience and past performance:** The bidder firm may be Manufacturer/Proven supplier/Authorized dealer or distributor of tendered item or bidder may participate with manufacturing authorization form (issued by manufacturer of tendered item).

**Note:** Participating bidder needs to submit all related documents along with the bid. In case, bidder is manufacturer/Proven Supplier/Authorized dealer or distributor of tendered item, then bidder has to submit relevant document for the same. **III) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)

**IV) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

**V) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.

**VI) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.



### VII) Undertaking:-

### VIII) Note:

- a) Interested firms are requested to submit the above required documents sealed and signed on all pages along with Bid.
- b) No further correspondence will be made with the bidders for shortfall of documents, if any; such offers with partial submission of documents will be summarily rejected.
- c) The Bid should be completed in all the respect including submission of all the required documents so that further clarification may not be called for.
- d) "**Anti-Bribery Management System (ABMS):** *By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.*"

**IX) Delivery Schedule:** - The Supply shall be completed within 30 days from the date of issue of Contract.

**X) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

**XI) Payment Terms:** - 100% Payment will be released within 10 days from the issue of CRAC Report, Submission of Bills and acceptance of the goods by ISP.
