**X) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/ Services wit hin the original / re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to dedu ct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions afore said, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any c ontroversy/dispute of any sort whatsoever.

**XI) Payment Terms: -** Payment will be released within Thirty (30) days of issue of Consignee Receip t-cum Acceptance Certificate (CRAC) and submission of bills.

**XII)Anti-Bribery Management System (ABMS):** By participating in this tender, the suppliers/Vend ors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-f inancial bribe, to or from anyone during the tender or during the execution of the contract thereafter a nd if they notice any such incident happening, they shall report it to Vigilance.

XIII) Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1,2 and 3) F. (2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alo ne or together, or through one or more juridical person, has ownership of entitlement to more than fift een percent of Capital or profits of the partnership.

(3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has owners hip of or entitlement to more than fifteen percent of the property or capital or profits of such associati on or body of individuals;

(4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.

(5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author o f the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any othe r natural person exercising ultimate effective control over the trust through a chain of control or owne rship

(vi)An Agent is a person employed to do any act for another, or to represent another in dealings with t hird person.
