- 2. The ink shall be suitable for use on uncoated Maplitho paper and should be able to produce sharp result.
- 3. After printing, the ink shall be snudged proof and water and solvent resistant.
- 4. The ink shall be suitable for use at machine speed of 120 m/ min or higher and shall dry properly.


