- 1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 2. Capability, Equipment & Manufacturing Facilities:

The bidder firm has an annual capacity to supply at least one number of "Supply, installation, Testing and Commissioning of Dedicated Fire Hydrant System on Turnkey basis with same or higher specification of the requirement.

3. Financial Standing:

Iii) the bidder (manufacturer or prin cipal of authorised representative) furnishes along with the bid a legally enforceable undertaking jo

intly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warra nty obligations as per the general and special conditions of contract.

- b) **Authorized Representatives**: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer m eets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warra nty obligations as per the general and special conditions of contract; and iii) the bidder himself sho uld have been associated, as authorised representative of the same or other Principal Manufacture r for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 31.0 3.2024.
