1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Technical Specification for Precious Document Protective Acid and Moisture Free and Non- Bleaching Sheet:

- The protective sheet will be double folded.
- The protective sheets should have Clear transparency – crystal clear view of the stamps.
- Standard: Open on two / three sides. The reverse foil should be transparent / black.
- A reinforced cover foil with clamping should provide stability and safety for many years.
- The extra strong clamping action of the mounts should securely hold the stamps in place preventing them from slipping out.
- The materials should be free of plastizers and harmful chemicals. The material should be preferably made of Polystrol, a proven archival quality material that will not damage stamps. The material should acid free and non-bleaching.

- Black/White backed and Standard (top opening)
- The sheets should protect the precious documents from dust, creases and tears while keeping the stamp gum intact.
- The sheets should be Easy to use – simply lift one flap on the back and gently slide stamp in face-down. Then lift the other flap and lay the stamp inside.
- There should be option to choose between a clear background or a black background. Both should be made of virgin polystyrene – proven to be safe for long term archival storage of stamps.
- The thickness of the sheet should be 0.16mm to 0.20mm
- The size of the sheets will be of the following sizes:
 - 24 inches (L) x 18 inches (B), Qty-3000 Nos
 - 22 inches (L) x 22 inches (B), Qty-2000 Nos
- A separate punching slot of ½ inch width should be provided on the left-hand side of the sheet.

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid: -

I) For MSE/Start-up firm: Capability - Equipment & Manufacturing Facilities: The bidder firm should have capability to manufacture and supply of precious document protective acid & moisture free and non-bleaching sheet as per attached technical specifications.

II) For other firm - Experience and past performance: The bidder firm may be Manufacturer/Proven supplier/Authorized dealer or distributor of tendered item or bidder may participate with manufacturing authorization form (issued by manufacturer of tendered item).

Note: Participating bidder needs to submit all related documents along with the bid. In case, bidder is manufacturer/Proven Supplier/Authorized dealer or distributor of tendered item, then bidder has to submit relevant document for the same. In case, bidder is not manufacturer/Proven Supplier/Authorized dealer or distributor of tendered item, then bidder has to submit manufacturing authorization form (issued by manufacturer of tendered item).

III) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)

IV) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeatedly) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

V) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.

VI) Goods & Service Tax Registration (GST): The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

VII) Undertaking:-

VIII) Note:

a) The Indian agent on behalf of the Principal/ OEM or principal/OEM itself can bid but both cannot bid simultaneously for the same item/ product in the same Bid. If an agent submits bid on behalf of the Principal/ OEM, the same agent shall not submit a bid on behalf of another Principal/ OEM in the same Bid for the same item.

b) Interested firms are requested to submit the above required documents sealed and signed on all pages along with Bid.

c) No further correspondence will be made with the bidders for shortfall of documents, if any; such offers will

ith partial submission of documents will be summarily rejected.

d) The Bid should be completed in all the respect including submission of all the required documents so th at further clarification may not be called for.

e) **“Anti-Bribery Management System (ABMS):** *By participating in this tender, the suppliers/Vendors/ Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they no tice any such incident happening, they shall report it to Vigilance.”*

IX) Delivery Schedule: - The Supply shall be completed within 60 days from the date of issue of Contract .

X) Quantum of LD:- If the Seller/Service Provider fails to deliver any or all of the Goods/Services within th e original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover t he Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated da mages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of an y sort whatsoever.

XI) Payment Terms: - 100% Payment will be released within 30 days from the issue of CRAC Report, Sub mission of Bills and acceptance of the goods by ISP.

XII) Note regarding MSE and MII purchase preference:

For MSE Purchase Preference:

Instant bid is non-splitable / non-dividable in nature. Therefore, in case L1 is non-MSE then MSE firm quotin g price within L1+15% band will be awarded full tendered quantity subject to matching the L1 prices.

For MII Purchase Preference:

For goods and works where the requirements are not divisible in nature

a) Among all qualified bids, the lowest bid will be termed as L1. If L1 is ‘Class-I local supplier’, the contract will be awarded to L1.

b) If L1 is not ‘Class-I local supplier’ the lowest bidder among the ‘Class –I local supplier’, will be invited to match the L1 price subject to Class-I local supplier’s quoted price falling within the margin of purchase pre ference i.e. L1+20% band, and the contract shall be awarded to such ‘Class-I local supplier’ subject to mat ching the L1 price.

c) In case such lowest eligible ‘Class-I local supplier’ fails to match the L1 price, the ‘Class-I local supplier’ with the next higher bid within the margin of purchase preference i.e. L1+20% shall be invited to match th e L1 price and so on and contract shall be awarded accordingly. In case none of the ‘Class-I local supplier’ within the margin of purchase preference matches the L1 price, the contract may be awarded to the L1 bid der.

XIII) Clarification of Bids/Shortfall Documents: During the evaluation and comparison of bids, the pur chaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. Seven da ys). If the bidder does not comply or respond by the date/period (i.e. within Seven days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at t he initiative of the bidder shall be entertained.

Note: While submitting the Clarification/Shortfall Document any technical difficulty occurs on GeM portal, t hen the bidder can submit the Clarification / Shortfall Document through e-mail (e-mail id:purchase.isp@sp mcil.com).

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
