- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - **XIV) Manufacturer's authorization letter**: In case the bidder firm/ Bidder offers to supply of the tender ed products which is manufactured by some other firm, the Bidder has to be duly authorized by the manuf acturer of the stated plant to quote for and supply and install the same to India Security Press, a unit of SP MCIL.
