Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 5. ## 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid: -

- **I) For MSE/Start-up firm: Capability Equipment & Manufacturing Facilities:** The bidder firm shoul d have capability to manufacture and supply of similar kind of Pneumatic cylinders as per attached technic al specifications.

- **III) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three pr ocurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **IV) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repe at cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **V) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitte d.
- **VI) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Ta x (GST). Relevant proof of registration Certificate shall be submitted.

#### VII) Undertaking:-

#### VIII) Note:

- a) The Indian agent on behalf of the Principal/OEM or principal/OEM itself can bid but both cannot bid simu ltaneously for the same item/ product in the same Bid. If an agent submits bid on behalf of the Principal/OEM, the same agent shall not submit a bid on behalf of another Principal/OEM in the same Bid for the same item.
- b) Interested firms are requested to submit the above required documents sealed and signed on al I pages along with Bid.
- c) No further correspondence will be made with the bidders for shortfall of documents, if any; such offers w ith partial submission of documents will be summarily rejected.
- d) The Bid should be completed in all the respect including submission of all the required documents so th at further clarification may not be called for.
- e) "Anti-Bribery Management System (ABMS): By participating in this tender, the suppliers/Vendors/ Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they no tice any such incident happening, they shall report it to Vigilance."
- **IX) Manufacturer's authorization**: In case the bidder firm/ Bidder offers to supply of the Pneumatic Spar

es which is manufactured by some other firm, the Bidder has to be duly authorized by the manufacturer of the stated plant to quote for and supply and install the same to India Security Press, a unit of SPMCIL. The Bidder shall submit the manufacturer's authorization letter to this effect.

**X) Delivery Schedule: -** Within 90 days from the date of issue of Contract.

**XI) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of a ny sort whatsoever.

**XII) Payment Terms:** - Payment will be released within thirty (30) days of issue of Consignee Receipt-cu m Acceptance Certificate (CRAC) and submission of bills.

**XIII) Clarification of Bids/Shortfall Documents:** During the evaluation and comparison of bids, the pur chaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. Seven days). If the bidder does not comply or respond by the date/period (i.e. within Seven days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.

**Note:** While submitting the Clarification/Shortfall Document any technical difficulty occurs on GeM portal, then the bidder can submit the Clarification / Shortfall Document through e-mail (e-mail id: <a href="mailto:purchase.isp@spmcil.com">purchase.isp@spmcil.com</a>).

The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall informatio n/ documents only in case of historical documents that pre-existed at the time of the Bid Opening, and whi ch have not undergone change since then and does not grant any undue advantage to any bidder. As far a s the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and considered.

For example, if the bidder has submitted a supply order without its completion/performance certificate, the certificate will be asked for and considered. However, no new supply order shall be asked for to qualify the bidder.
