- (b) That there is no agency commission involved in the supply and that no person is paid agency commission in India.
- (iv) A brief technical write up on the items offered may be enclosed along with the manufacturers certificate.
- (v) 100% Payment will be made after receipt of material herein good condition and its successful installation and acceptance and on production on all required documents.
- (vi) Security Deposit: You have to submit 3% of the total cost of the Purchase Order against security deposit in the form of DD/ FDR/ Bank Guarantee drawn on any scheduled Commercial bank in India only in the favour of "India Security Press, Unit of SPMCIL" within 21 days from the date of issue of "Notification of Award of Contract (NAC)". - 1. Synrad make water cooled CO2 100 W Laser Source Model Ti100-10.6µm along with the Power supply unit (SMPS)
- 2. Installation, Testing and Commissioning of the 100W CO2 Laser Source in the Sheet Master Flex Laser Perforation machine.

#### Terms and Conditions:

- 1. The offer submitted by the firm must be complete in all respect on turnkey basis (CO2 water cooled laser source 100W Ti100 model of Synrad make and power supply Unit and no further enhancement of cost will be considered against raising issues by the firm at later stage.
- 2. Mechanical adaptation (HARDWARE) is to be done by the firm at their own cost. Since the existing model of FSD100FS (Working and obsolete model) dimensions are different from the new and proposed model of Ti100, Fabrication to suit to the Laser Source has to be carried out the firm in complete.
- 3. The firm will have to take all safety precautions while carrying out of installation of the offered system on the existing MLT Machine of ISP.
- 4. Warranty period: 01 year after Final Acceptance Certificate (FAC).

#### INSTALLATION, TESTING COMMISSIONING AND TRIALS:

1. The firm shall depute their Engineers/ Technicians to India Security Press, Nashik for installation, Commissioning, Testing and Trials of the System for the required period of time at their own cost. The firm has to provide Operational and Maintenance training of the supplied system for Technical and Electrical staff of ISP after/ during commissioning of the system.

- 2. The new installed Laser Source should work as per the existing Laser source in all respects. If not met, a fresh FAT will be conducted for a period of another six (6) working days.


