**1. Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

**2. Buyer Added Bid Specific ATC**

The bidder firm should meet following eligibility criteria to qualify: -

- I. **For MSE/Start up firm** : - The bidder must have capability to provide the relevant services.
- II. **For other firm - Experience & Past performance** : - The Bidder should have experience of having successfully completed similar kind of services for the value at least Rs. 9.31 lakhs in any one of the last five years ending on 31<sup>st</sup> March 2024.
- III. **PAN**: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.
- IV. **Goods & Service Tax Registration (GST)**: The Bidder should be registered with Goods & Service Tax.

V. **Undertaking: -**

a) The bidder has to provide the undertaking that **“We M/s. <Name of the bidder firm> declaration that the firm has not been blacklisted/ debarred by any government agency / Public Sector Unit/ Reputed organization.”**

b) The bidder has to provide the undertaking that **“We M/s. <Name of the firm> agree to withdraw all the deviations, if any, unconditionally and accept all the Terms and conditions of the tender document including the technical specifications.”**

VI. **Certificate of Registration Carriage Act, 2007:** - Firm must submit Certificate of Registration on Carriage Act, 2007.

VII. **Payment Terms:** - Payment will be made as per actual trips within 30 days after satisfactory completion and acceptance of the service by the purchaser from time to time and after deduction of TDS (Tax Deducted at source) and other taxes, if any.

VIII. **Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the Purchase Order, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the Purchase Order value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the Purchase Order value of delayed quantity without any controversy/dispute of any sort whatsoever.

IX. **“Anti-Bribery Management System (ABMS):** *By participating in this tender, the suppliers/Vendors/ Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.”*

X. **Clarification of Bids/Shortfall Documents:** During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. Seven days). If the bidder does not comply or respond by the date/period (i.e. within Seven days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.

Note: While submitting the Clarification/Shortfall Document any technical difficulty occurs on GeM portal, then the bidder can submit the Clarification / Shortfall Document through e-mail (e-mail id: [purchase.isp@spmCIL.com](mailto:purchase.isp@spmCIL.com)).

The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall information/ documents only in case of historical documents that pre-existed at the time of the Bid O

pening, and which have not undergone change since then and does not grant any undue advantage to any bidder. As far as the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and considered.

For example, if the bidder has submitted a supply order without its completion/performance certificate, the certificate will be asked for and considered. However, no new supply order shall be asked for to qualify the bidder.
