If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers

offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

1. **For MSE/Start-up firm: Capability** - Equipment & Manufacturing Facilities: The bidder firm should have capability to supply the services as per tender document. The bidder has to provide the undertaking that **“We M/s. <Name of the firm> have the capability to supply the services as per tender documents.”**
2. **For other firm - Experience and past performance:** The bidder should have experience of having successfully supplied truck hiring services of at least Rs. 2,07,000/- in any one of the last five years ending on '31.03.2024.'

4. **PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.
5. **Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.
6. **Undertaking:-**

- The bidder has to provide the undertaking that **“We M/s. <Name of the firm> have not been blacklisted/debarred by Government of India/PSU/ Any reputed organization in the past”**.

7. **Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
8. **Contract Period-** Contract shall commence from the date mentioned in GeM Contract/Purchase Order for a period of One (01) Year. Vehicles shall be provided without driver and without fuel on monthly 24 X 7 basis.

### 9. SCOPE OF WORK VEHICLE-TRUCK BS-VI

- a. Hiring of vehicle-Truck BS-VI for CISF unit at India Security Press, Nashik. The Truck provided by the bidder shall be in good running condition, good interior & exterior in all respects and not run more than 01 years (Year 2022) BS-VI model (Not run more than 30000K.M). Vehicle follows latest norms and taxi permit, without driver and without diesel. Vehicle to be available 24 hours for the period of one year with valid permit to use within Maharashtra & Other States (if required).
- b. **Rates:**
  - I. The rate should be quoted with travel up to 1000 KM on per month on 24x7 basis.
  - II. Extra per Kilometre charges - Monthly package cost divided by no. of kilometres in Monthly package multiplied by 0.2 in case of 24x7 services.

- c. Vehicle should be fitted with fastag and fastag statement should be submitted along with monthly bill for payment. Minimum fast tag balance Rs.1000/- at all time to be maintained.
- d. Period of Contract: The vehicle will be initially hired for a period of 01 Year. Performance of service provided will reviewed after every 03 months. ISP shall have the option to increase the period by 25% i.e. 3 months on the same rate, terms and condition.
- e. Vehicle: The vehicle required is Tata Troop Carriers LPT 710 or equivalent WITH BS-VI standard with foot rest attached on rear side". High Side Deck vehicle should be Cover top by using water proof tarpoline/tripal and provide detachable bench to sit both side.
- f. Permit: Vehicle follows latest norms of Road Transport Office and should have valid taxi permit to use within Maharashtra. If vehicle goes outside from Maharashtra, Contractor will arrange required documents and permit for the same. Permit fees will be paid to contractor by India Security Press, Nashik if Receipt/ proof attached in bill.
- g. Duty Timings: The vehicle is required for 24 Hours at India Security Press, Nashik.
- h. The fuel (HSD) shall be provided by India Security Press, Nashik. The running maintenance / Breakdown repairs, all type of repairs and preventive maintenance, Oiling and greasing of the vehicle shall be arranged by the contractor at his own cost.
- i. Registration of vehicle, fitness, Insurance, Pollution certificate, RTO Document and other required document will be maintained by the bidder.
- j. The contractor shall get the vehicle insured comprehensively at his own cost for covering all the risks. He will be responsible for compensation payable arising out of any accident including any payment to the third party, if imposed. No liability towards India Security Press, Nashik. Any compensation on account of accident or damage to the vehicle or for death of any third party / ISP employee or injury or loss, if any, shall be borne by the contractor with no liability towards ISP.
- k. Tenderer must possess PAN Card and Xerox copy of the PAN Card should be submitted along with quotation.
- l. If hired vehicle is sent for servicing or maintenance, other similar vehicle should be provided free of cost by the bidder and no additional payment will be made for the same by ISP.
- m. The participating bidder must possess taxi operator license issued by RTO. This license must be valid on date of opening of tender.

**10. Payment Terms-** This section provides details about the terms and conditions of payment towards the services; it may include deduction of payment in case of faculty service.

**11. Payment Condition-**

- a. The payment shall be made on Monthly Basis as per the financial quotes submitted by the Service Provider and accepted by the Buyer.
- b. No advance payment shall be made to the Service Provider.
- c. The quoted price shall cover all aspects of service delivery, it shall be inclusive of all consumables required to provide the service.
- d. Nonetheless, any charges borne by the Service Provider with respect to toll charges, parking fee or entry taxes shall be reimbursed on actual basis upon submission of proof of payment.

**12. Payment Cycle-**

- a. Payment shall be made once the services provider submits the invoice for the same as per the prescribed process flow.
- b. The Buyer shall make the payment within prescribed timelines as per the payment process flow upon submission of invoice, logbook and service feedback.

**13. Payment Process-**

- a. Payment shall be made only after submission of invoices, logbook, service feedback, n

on-submission of the same may lead to delay/deduction of payment.

- b. All the penalties/fine/interest (if applicable) will be settled before making the payments . Service Provider shall not have any objection on the same.
- c. Payment will be made through bank transfer only, in no circumstance cash/cheque payment will be made.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any

- Category item bunched with it.
4. Creating BoQ bid for single item.
  5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
  6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
  7. Floating / creation of work contracts as Custom Bids in Services.
  8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
