# B. Service Visits by the representative/(s) of the firm:

- a. The firm's Engineer/ Technician will have to visit on quarterly basis to carry out the routine maintenance/ service of the XBIS and have to submit their service report (minimum 2 visits in a quarter.)
- b. Besides this quarterly visit, the firm has to send their Engineer/ Technician within 24 hours of the breakdo wn/ service call during the CAMC period and as many calls as required and to solve the problem/fault within 24 Hours.
- c. If in any case, ISP's X-Ray Baggage Inspection machine goes under breakdown for than 24 hours then the successful bidder must provide similar X-Ray baggage Inspection machine to ISP so that X-Ray Baggage In spection machine service must be maintained uninterrupted. #### **Clarification of Bids/Shortfall Documents:**

During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. three days). If the bidder does not comply or respond by the date/period (i.e. within three days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.
