1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of guality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. 4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India). Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

5. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and

hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity + Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

3. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

I) For MSE/Start-up firm: Capability - Equipment & Manufacturing Facilities: The bidder firm sh ould have capability to manufacture and supply at least 12,000 Nos. of Opp Corrugated Boxes in S ize of 470mm X 270mm X 260mm.

II) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of aut horized representative) who is a successful past supplier of 'The Product' in at least one of the rec ent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Govern ment of India from time to time.)

III) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be s ubmitted.

IV) Goods & Service Tax Registration (GST): The Bidder should be registered with Goods & Se rvice Tax (GST). Relevant proof of registration Certificate shall be submitted.

V) Undertaking: -

- a) The bidder has to provide the undertaking that "We M/s. <Name of the firm> have not been blacklisted by Government of India/ PSU/any reputed organization i n the past".
- b) The bidder has to provide the undertaking that "We M/s. <Name of the firm> agre e to withdraw all the deviations, if any, unconditionally and accept all the Ter ms and conditions of the document including the technical specifications."

VI) Quantum of LD:- If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditi ons aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of d elayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

VII) Payment Terms: - The payment terms are 100% within 30 days after successful supply of th e item and acceptance of the same by ISP.

VIII) Anti-Bribery Management System (ABMS): By participating in this tender, the suppliers' /Vendors/ Contractors are deemed to have undertaken that they shall not give or take, any financi al or n on-financial bribe, to or from anyone during the tender or during the execution of the contract there after and if they notice any such incident happening, they shall report it to Vigilanc e."

IX) Ministry of Finance, Department of Expenditure, Public Procurement Division, Order s (Public Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23rd/24th July 2020 (or a ny further amendments thereof) regarding eligibility of bidders from specified countrie s shall be applicable to this tender. SPECIFICATION OF OPP CORRUGATED BOX

A). Size of Box (Internal Dimension L x W x H in mm)-470x270x260mm

(As per attached Sketch; Tolerance \pm 5mm for these dimensions.)

B) Characteristics of Corrugated Box

1) 5 ply Broad flute. Flute direction should be vertical.

2) Top layer to be covered with bituminized tar waterproof paper of 220 gsm and reinforced with j ute cloth of minimum 180 gsm.

3) Paper to be used: 300 GSM Liner Kraft paper 'A 'grade

4) Bursting Strength of the board: Min 30 kg/cm2

5) Adhesive to be used: Very strong, best quality of low moisture absorbency.

6) Compression strength: 600 Kgs. (Empty Box)

7) Cobb Valve: All papers must be of low Cobb (below 30).

8) Box outer and inner surface should be water resistant but outer surface should be capable of ho lding stencil ink (Solvent: turpentine)

9) To be printed with Code Mark identification (Code mark 'XXX' will be provided to successful tenderer)

10) General Workmanship & Finish shall be good throughout.

11)Two slots at each side i.e front and back side of box, having 1/4th distance from both ends and one slot at center on left and right side of box.. The slot size required to be of 15 mm for holding o f steel/nylon strips.

12) Both the corners of flap should be curved so that flap canbe inserted easily.

B. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement (To be su bmitted on firm's Letter Head as a token of acceptance): -

1) Pre-Dispatch Sample: - A Sample of 2 Boxes are to be submitted free of cost for approval, be fore bulk Supply. Sample must be submitted within 30 days of issue of Supply Order, ISP will issue suitability of sample within 15 days of receipt of sample.

2) Testing: Testing of GSM will be done as per IS 7063 (Part IV)- 1976. Testing for bursting strengt h of the board and water absorption of the outer surface will be done as per IS2771 (Part I)- 1977.

3) Delivery Schedule: - The total quantity is to be supplied in10 equal monthly instalments after suitability of sample.

1st lot of 3000 qty. - within 45 days to 75 days

2nd lot of 3000 qty. -within 75 days to 105 days

3rd lot of 3000 qty.- within 105 days to 135 days

4th lot of 3000 qty.- within 135 days to 165 days

4) Each of the above delivery shall be proportionally placed as per parallel contract/bid splitting co ndition.

5) Quality Control Requirement: -

(i) The material supplied by the successful bidder will be accepted on all parameters as per specifi cation provided in the Bid Document. The purchaser reserves the right to get the material supplied tested from in-house laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desir ed, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.

(ii) After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is notic ed then the same will be replaced free of cost by the supplier/seller up to India Security Press, Nas hik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

C. Special Conditions of Contract (SCC):

1) Transportation of Goods: The transportation of goods to be procured will be done by the supplie r on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the it em to be procured.

2) Insurance: Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore the cost of the insurance will also the part of the cost of the material borne by the suppli er. A specific insurance cover for each consignment/supply is to be given by firm, as applicable.

3) Distribution of Dispatch Documents for Clearance/Receipt of Goods: The supplier shall send all t he relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.

4) Taxes and Duties: Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. inc urred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and du ties asper law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

5) Terms and Mode of Payment: 100% payment will be released within ten (10) days of issue of co nsignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment w ill be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TD S, if any, will be deducted as applicable.

6) Bid Splitting/Parallel Contract: India Security Press, Nashik reserves its rights to conclude Bid Sp litting/Parallel Contract with more than one bidder (maximum upto Three bidders for the same ten der) without any prejudice to the capacity of the L1 bidder. In case of splitting in three, the ratio of 70:30will be used.

7) NOTE:

i. All experience, past performance and capacity/ capability related/ data should be certified by the authorized signatory of the bidder firm.

ii. Decision on Finalization of tender will be taken based on the documents submitted along with th e tender. All documents must be submitted as per tender requirement failing which offers will be li able for rejection.
