I) For MSE/Start-up firm: Capability - Equipment & Manufacturing Facilities: The bidder firm s hould have capability to supply the services as per Tender Document. The bidder firm has to pro vide the undertaking that "We M/s. <Name of the firm> have the capability to supply the services as per tender document."

II) For other firm - Experience and past performance: The bidder firm should have experie nce of having successfully supplied the services of at least Rs.4,24,800/- in any one of the last fiv e years ending on 31.03.2024.

III) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.

IV) Goods & Service Tax Registration (GST): The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

V) Undertaking:-

1. Only 2x2 recess type LED panels will be supplied by ISP.

2. The quantity mentioned is tentative and may vary according to the requirements of ISP.

3. During the fixing of LED panels, if there is any damage to ceiling of section, firm should r epair damaged part of ceiling without any extra cost to ISP.

4. Firm should quote rates/ price including discount/rebates if any in any form in the techno commercial offer.

5. Makes of supply wire/cable – FRLS type Polycab, Finolex, Havells, or exact equivalent ma kes.

6. ISP will not provide any tools, equipment, spares to perform the fixing job work.

7. Payment will be done at actual after successful completion of job work.

8. The rates should be inclusive of all incidental charges i.e. taxes, duties, material, labour c harges, GST etc.

9. Prior to quote, if required, firm's representative may visit the site with prior permission of ISP's competent authorities along with valid copy of Police verification certificate to survey actua I scope of work to avoid any ambiguity in latter stage.

10. Firm should offer minimum 90-days warranty for the job work done.

11. While submitting offer firm should consider the scope of job work and material required w hich is not mentioned but required to complete the job.

12. If the fixing of LED panels is found faulty or fall down within the warrantee period, firm ha s to rectify & do the proper fixing of fitting free of cost.

13. Working hours: - 8.00am to 4.30pm (excluding Lunch hour). As per requirement however, at the discretion of ISP authorities permission may be given to continue the work during lunch-ho ur, Sunday/Holiday.

14. All the tools, tackles, drill machine, safety equipments such as hand gloves, helmet, insul ated ladder, goggles, safety shoes, skilled / unskilled labour required for the work is to be arrang ed by the firm. ISP will provide free electricity supply only.

Note: - Without personal protective equipments & insulated ladder work will not be permitted.

15. All the waste created during the work such as wires, cables, metal pieces, old used Materi al, replaced/removed tubelight fittings should be shifted by the firm to the scrap yard ISP.

16. The firm should submit the bill in triplicate duly signed and stamped.

XI) Bidder must submit check list of below mentioned documents:-

1. Clarification of Bids/Shortfall Documents:

During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. three days). If the bidder does not comply or respond by the date/period (i.e. within **three days**), his tender will be liable to be rejected.
