6. I) For MSE/Start-up firm: Capability - Equipment & Manufacturing Facilities: The bidder firm should have capability to manufacture and supply of Tender Products. We **M/s. <Name of the firm>** have the capability to supply the services as per tender document.

II) For other firm - Experience and past performance: The bidder should have experience of having successfully supplied the services of at least Rs. 3.78 Lakhs Only in any one of the last five years ending on **31.March.2024**.

III) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.

IV) Goods & Service Tax Registration (GST): The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

V) Undertaking:-

Terms and Conditions for Annual Medical Examination:

1. Medical Examination shall be conducted by Certifying Surgeon and report to be given in Form no. 7 (Health Register) of The Factories Act, 1948. (Annexure-I)
2. Form no. 7 - Health Register (duly certified by Certifying Surgeon) shall be provided in hard copy (Two copies) & soft copy to ISP.
3. Certifying Surgeon should have valid registration number and recognized by Directorate of Industrial Safety & Health, Maharashtra State. (Documents to be provided by firm).
4. According to directions issued by Dy. Directorate of Industrial Safety & Health (DISH), Nashik Division, Nashik via letter क्र ससंऔसुवआ/वै.त./निमजा/17171765/2024 dated 20-06-2024, Certifying Surgeon should notify DISH office via "Online Portal and Mobile Application" & follow other guidelines as prescribed in the said letter. The same letter is enclosed as Annexure-II for reference.
5. The firm should have valid license of equipment and machines used for investigations. (e.g. AER B license for X-Ray Machine etc.)
6. Tendering bidding company has to conduct the exam and present all employees individual reports to ISP.
7. For medical examination (i.e. for ECG & X-Ray, etc.) of female employees, female staff should be provided.
8. All medical examination/investigations of an employee shall be conducted on the same day.
9. The Biomedical Waste generated during investigation shall be disposed by the firm as per norms and regulations. (For e.g. Sharp needle, blood swab, cotton roll of ECG etc.)
10. Firm shall ensure proper storage of collected Blood samples for proper testing and reporting as per medical standards. During PFT Test, mouth gag of PFT equipment should be properly cleaned and should be covered with disposable tissue paper.
11. The firm should appoint qualified & experienced Doctors and Certified machines technicians for conducting health checkup. 12. The firm should provide Identity Card and Police Verification Report of officials deployed at ISP for conducting Medical Examination.

Clarification of Bids/Shortfall Documents:

During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (**i.e. three days**). If the bidder does not comply or respond by the date/period (**i.e. within three days**), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.

Note: While submitting the Clarification/Shortfall Document any technical difficulty occurs on GeM portal, then the bidder can submit the Clarification / Shortfall Document through e-mail (e-mail id: purchase.isp@spmCIL.com).

The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall information/ documents only in case of historical documents that pre-existed at the time of the Bid Opening, and which have not undergone change since then and does not grant any undue advantage to any bidder. As far as the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and considered.

For example, if the bidder has submitted a supply order without its completion/performance certificate, the certificate will be asked for and considered. However, no new supply order shall be asked for to qualify the bidder.
