2. Scope of Comprehensive Annual Maintenance Contract:

The firm shall have to repair/replace following parts of the XBIS as & when require d during the contract: -

B. <u>Service Visits by the representative/(s) of the firm:</u>

- The firm's Engineer/ Technician will have to visit on quarterly basis to carry out the routine maintenance/ service of the XBIS and have to submit their service report (minimum 2 visits i n a quarter.)
- 2. Besides this quarterly visit, the firm has to send their Engineer/ Technician within 24 hours of the breakdown/ service call during the CAMC period and as many calls as required.

C. Payment terms:

The 100% payment shall be made within 30 days on completion of every quarter after succe ssfully carrying out of the routine maintenance and attending of breakdown/service calls during that quarter along with satisfactory report by the ISP authority.

D. General terms & Conditions:

- 1. The bidder should have ISO certification for manufacturing and servicing of X-Ray Screening machines. The copy of the certificate shall be submitted along with their offer.
- 2. The bidder must submit OEM authorisation certificate.
- 3. The firm is required to intimate the name of the person visiting for maintenance or repairs well in advance with details of the representative/(s) visiting, period of visit, time of visit alon g with his/their identity card.
- 4. The firm has to certify with quarterly Service report that, X-ray radiation & safety performa nce standard of the XBIS are well within the range and meeting its guidelines as per the standard of 'Atomic Energy Regulatory Board of India (AERB)'.

Clarification of Bids/Shortfall Documents:

During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the b idder for clarifications on the bid. The request for clarification shall be sought only once on G eM portal, asking the bidder to respond by a specified date/period (i.e. three days). If the

bidder does not comply or respond by the date/period (i.e. within three days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid cl arification at the initiative of the bidder shall be entertained.
