- 1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - 7. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. Checking Throughput, overall imaging quality, imaging tools, image saving and retrieval, recalling a min imum of 30 or more previous images steel penetration, wire detectability, contrast sensitivity, scanning sp eed, maximum dimensions of target to be scanned, operator environment, daily log of events, report gene ration, CTP Testing (Testing 1 to 6) with Method mentioned on point no 50 etc.
- 4. Single wire resolution: 40 SWG,
- 5. Useful penetration: 30 SWG under second wedge,
- 6. Material descrimination: Sugar (orange) & salt (green),
- 7. Simple penetration: lead strip visible till 35mm,
- 8. Special resolution: Vertical & Horizontal copper gratings visible clearly,
- 9. Thin Metal Imaging: 0.1 mm metal should be visible etc.

Its operation and troubleshooting training must be provided to CISF personal and ISP representative for 5 d ays at ISP site.

# XIII) Performance Security:

- a. For SITC of AI Based X ray baggage system: The GeM contract will be placed for SITC of AI b ased X-ray baggage system along with one-year standard comprehensive warranty and 4-year CAMC post completion of standard comprehensive warranty. But, initially the work to be exec uted for SITC of AI Based X ray baggage system along with standard one-year comprehensive warranty. **XVI) Payment Terms: -** a. For SITC:- 100% will be released within 30 days after successful FAT of SITC of Al based X-Ray Baggage Inspection System with standard one year comprehensive warranty.

b. During CAMC:- The 100% payment shall be made within 30 days on completion of every quarter after su ccessfully carrying out of the routine maintenance and attending of breakdown/service calls during that qu arter of CAMC along with satisfactory report by the ISP authority.

XVII) Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23<sup>rd</sup>/24<sup>th</sup> July 2020 (or any further a mendments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender.
