- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. - 2. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. Buyer Added Bid Specific ATC

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

**I) Experience and past performance**: The Bidder should have manufactured and supplied at le ast one number of "Forklift" with the same or higher specifications in the last five years ending on 31st March 2024. At least one number of the product offered for supply should be in successful op eration for at least one year on the date of bid opening.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidd er / manufacturer firm(s) might be undertaken by a Committee or through a third party Technical Consultancy / Inspection agencies to ensure that the firm is/are identified and capable to supply the machine/item/material/product as required.

- **III) For Existing successful Past Suppliers**: In case the bidder (manufacturer or principal of aut horized representative) who is a successful past supplier of 'The Product' in at least one of the rec ent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Govern ment of India from time to time.)
- **IV) Financial Turnover/Standing:** The average annual Financial turnover of the bidder firm duri ng last three year, ending on 31.03.2024, should be at least Rs.25,00,000/- as per the annual report of the relevant period duly authenticated by a Charted Accountant/Cost Accountant in India or e quivalent in relevant countries.

## V) Applicability in Special Cases:

- a) Applicability to 'Make in India': (manufacturer or principal of authorised representative) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. Iii) the bidder (manufacturer or principal of authorised representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.
- **b) Authorized Representatives:** Bids of bidders quoting as authorised representative of a princ ipal manufacturer would also be considered to be qualified, provided: i) their principal manufactur er meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a le gally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder hims elf should have been associated, as authorised representative of the same or other Principal Manu facturer for same set of services as in present bid (supply, installation, satisfactorily commissionin g, after sales service as the case may be) for same or similar 'Product' for past three years ending on 31.03.2024.

### (A) Scope of work during Comprehensive Warranty of Battery-Operated Forklift.

- 1. Check the brake fluid level in Brake oil container provided on the cowl.
- 2. Brake and inching pedal should be checked for free travel. Depress foot pedal and hold fo ot pressure for at least ten seconds. Pedal must be solid. It should not be spongy or should not drift under foot pressure. No depress pedal by hand. When it meets resistance from the Master cylinder, the distance travelled should be at least 3mm.
- 3. Check hydraulic tank breather to be sure that it is not dirty or clogged with foreign matter. Replace breather if dirty.
- 4. Check lift and tilt cylinders for drift, leakage at packings, damage and security of mounting.
- 5. Adjust the lift chains if required.
- 6. Inspect Lift Carriage for damage and bent forks etc.
- 7. Check the parking brake, fully apply brake by moving brake lever from full forward to full r ear position. Cable tension should be strong enough so that the lever hesitates or remains in a vertical position before continuing on as the lever passes through centre position tofull rear position.
- 8. Check contactor tips. Clean or replace if necessary.
- 9. Check the battery, the electrolyte should be at the proper level. Check the specific gravity. It should be 1.230 at 27°C. Clean the battery top, terminals and cables. Make sure that all the connections are tight.
- 10. Check & repair functioning of the Horn, Break and Safety Switch, operating control switches, handle.
- 11. Check & repair Electrical system, clean by air or brush. Clean and dry contactors.
- 12. Check for wear and tear of motor brushes. Clean the brushes.
- 13. Check level of Hydraulic oil and operate the carriage and check for any Leakage in the system and repair it.
- 14. Check & repair movement of guide plate, wear on roller and grease.
- 15. Check & repair setting of roller and adjust as necessary.
- 16. Check wear on wheels and condition of bearings.
- 17. Lubricate all moving parts.
- 18. Tighten all bolts fasteners, electrical connections, Check for performance of all safety de vice.
- 19. Check the mast stop for wear and tear. Clean the mast profile. Check for damages. Grea se the roller tracks.
- 20. Check the steering and make the adjustment if required.

- 21. Check commutator for damage wear and tear if dirty, blow out dust.
- 22. Carry out "Hydraulic System Checks".
- 23. Check Lift Carriage and Upright Roller adjustment.
- 24. Check motor brush and change if necessary.

## (C) Terms and Conditions:

- 1. The Bidder will have to attend 1 visit per month for preventive maintenance in consultatio n with India Security Press Nashik.
- 2. All types of repairs (whenever & wherever required), has to attend within 24 hours after re quest is made through email. Tools and tackles are to be provided by Bidder for attending ma intenance.
- 3. Manufacturing Year of Forklift, battery and charger must be 2025.
- 4. The Bidder shall carry out maintenance of forklift under the warrantyas per the scope of w ork. Servicing includes Engine overhauling, Hydraulic system overhauling, upright assembly o verhauling, drive axle and brake overhauling, routine check-up and spares replacement if any . Replacement of Miscellaneous spares if any like hand brake cable, brake paddle pad, horn, air filter hose, driver overhead guard, hydraulic hoses, hydraulic pump, Drive motor/pump m otor carbon brushes, bearings, lift chains, driver seat assembly, battery and charger related i ssues etc will be under the scope of bidder.
- 5. The Bidder shall ensure that the service engineer abides by all security regulations imposed by the India Security Press Nashik, and does not in any manner compromise security of India Security Press Nashik, property/area.
- 6. The Bidder should have qualified and experienced trained personnel for carrying out the c omplete Preventive maintenance, breakdown maintenance and major overhaul of forklift und er comprehensive warranty.
- 7. For Spare Parts: All spares and consumables required for servicing will be supplied by bid der. Bidder has to keep stock of required spare parts and consumables in ISP or in their custo dy to be used as and when required basis.

- **Electrical Components:** Ensure all lights, Head, tail, horn, and warning lights are w orking correctly.
- **Instruments and Gauges:** Verify the functionality of gauges, meters, and warning I amps.
- 4. Mechanical Systems:

- **Overhead Guard:** Verify the condition and proper function of the overhead guard.
- **Seat and Seat Belt:** Ensure the seat is in good condition and the seat belt is functional.
- **General Condition:** Look for any damage, loose parts, or signs of wear and tear.
- 6. Documentation and tool kit:
- Manuals: Verify the presence of the forklift's manual and any r equired documentation.
- Tool Kit: Verify the presence of basic essential tool kit in Forklift with list details.

### (E) Final Acceptance Test- Following will be checked at ISP site:
