6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM\_No.1\_4\_2021\_PPD\_dated\_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

## 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

## 3. Generic

**Manufacturer Authorization:**Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

## 4. Scope of Supply

- **2.** At the time of submitting the offer, bidder has to submit the sealed and signed bid document as an acceptance of all additional terms and conditions, technical specification and payment ter ms as mentioned in bid.
- **3.** The bidder firm should meet following eligibility criteria to qualify:

**A. Experience & Past Performance: -** The bidder should have manufactured and supplied te ndered item of at least 6800 ltr in any one of last five years ending on 31.03.2024.

**B. Capability, Equipment and Manufacturing facilities :** The Bidder must have an annual capacity to manufacture & supply at least 6800 ltr of tendered item.

- The bidder has to submit the following details along with the bid.
- (i) Name of the machine utilized to supply the quoted product.
- (ii) The number of machines being utilized for the production and the capacity of each mac hine.
- (iii) Total annual capacity of manufacturer.
- (iv) Supply orders in hand and proportionate capacity to supply quoted amount.

## C. Financial standing:

- (i) The average annual financial turnover of the bidder firm during last three financial years endi ng on 31st March 2024 should be more than Rs. 10,32,784/-.

4. Applicability to 'Make in India' :Bidders (manufacturer or principal of authorized represen tative) If the product is being manufactured in India under a license from a foreign manufacturer who hold s intellectual property rights and where there is a technology collaboration agreement/ transfer of technolo gy agreement for indigenous manufacture of a product developed abroad with clear phased increase in loc al content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experi ence and Past Performance above, would also be considered to be qualified provided: i) their foreign manu facturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in loc

cal content. Iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfa ctory manufacture, Supply (and erection, commissioning if applicable) and performance of 'HDPE woven b ag' offered including all warranty obligations as per the general and special conditions of contract.

- **5. For Authorized Representatives:** Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enfor ceable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligation s as per the general and special conditions of contract; and iii) the bidder himself should have been associa ted, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for s ame or **similar 'Intaglio Cleaning Solution'** for past three years ending on '31<sup>st</sup> March 2024'.
  - 6. For Existing successful Past Suppliers: In case the bidder (manufacturer or p rincipal of authorized representative) who is a successful past supplier of HDPE woven bag in at le ast one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not m eet any or more of requirements above, would also be considered to be qualified in view of their p roven credentials, for the maximum quantity supplied by him in such recent past to any units of S PMCIL.
  - **7. Joint Ventures and Holding Companies:** Credentials of the partners of Joint v entures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goo ds/Equipment, and each partner must comply with all the PQC criteria independently. However, fo r the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, w ith appropriate legal documents proving such ownership.
  - 8. **Start-up Enterprises:** Requirements of prior experience and turnover would be relaxe d for Start-up enterprises as recognized by Department for Promotion of Industry and Internal Tra de (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

# 9. Notes for Bidders:

- (i) Along with all the necessary documents/ certificates required as per the tender conditi ons, the bidder should furnish a brief write-up, backed with adequate data, explaining hi s available capacity (both technical and financial), for manufacture and supply of the re quired goods/ equipment, within the specified time of completion, after meeting all their current commitments.
- (ii) Supporting documents submitted by the bidder must be certified as follows:
- (iii) All copy of supply/ work order; respective completion certificate and contact details of clients; documents issued by the relevant industries department; National Small Industr ies Corporation (NSIC); manufacturing licence, annual report, etc., in support of experie nce, past performance and capacity/ capability should be authenticated by the by the p erson authorized to sign the tender on behalf of the bidder.
- (iv) All financial standing data should be certified by certified accountants, for example, C harted Accountants/ Cost Accountants in India and equivalent in relevant countries; and

- (v) Indian bidder or Indian counterparts of foreign bidders should furnish their Permanent Account Number.
- **10. LD Clause**<sup>1</sup> If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to o ther rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).
- **11.** "**GST Return**: Supplier should file the GST returns for outward supplies in time. In case of any In put credit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."
- **12. Capacity verification (if required)**: As part of technical evaluation, if required capacity verific ation of the bidders may be conducted by BNP. The offer of the firms not meeting the criteria in v erification as per bid document will be rejected.
- **13. Anti Bribery Clause -** "By participating in this tender, the suppliers/Vendors/Contractors are de emed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they not ice any such incident happening, they shall report it to Vigilance."
- 14. ZED & LEAN Certification: Government of India has launched scheme for obtaining ZED & L EAN certification to MSE vendors. Accordingly bidders are requested to obtain these certification t o ensure minimum wastage in production process which shall ultimately result In cost cutting & i mprovement in efficiency.

**NOTE:** These certification shall not have any impact on eligibility criteria for qualification in te nder.

- **15. Warrantee Clause:** The warranty shall be applicable only for 3 months from the date of last su pply/delivery. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a re asonable period, BNP may proceed to take such remedial action.
- **16. Quantity Tolerance:** The seller shall be allowed a tolerance of +/- 5% on the ordered quantity. This tolerance is to simplify logistical constraints and accounting of material. If seller supplies qua ntity beyond tolerance limit (except quantity procure through option clause) then such material s hall not be accepted and no payment shall be made for such supplies. Also if seller supplies less q uantity than tolerance limit within stipulated delivery period then it shall be consider as supply sh ortfall.
