If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Scope of Supply

4. Certificates

- 2. The participating firm has to submit sealed and signed bid document as an acceptance of all addition al terms and conditions, technical specification and payment terms as mentioned in bid.
- 3. **LD Clause:** If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½ % percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10 % of the delayed goods' or services' contract price(s).
- 4. "**GST Return:** Supplier should file the GST returns for outward supplies in time. In case of any Input c redit Loss to BNP by way of their failure to files GST returns in time, BNP reserves the right to withhold the payment of further supplies till production of evidence of filling of returns."
- 5. **Anti Bribery Clause -** "By participating in this tender, the suppliers/Vendors/Contractors are deeme d to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from a nyone during the tender or during the execution of the contract thereafter and if they notice any such i ncident happening, they shall report it to Vigilance."
- **6. Blacklisted Undertaking:** Undertaking/Declaration certificate that you are currently not suspended/ Banned/Blacklisted by any ministry/department of govt. of India or by any state govt. for business deal ing.
- 7. **ZED & LEAN Certification:** Government of India has launched scheme for obtaining ZED & LEAN certification to MSE vendors. Accordingly bidders are requested to obtain these certification to ensure minimum wastage in production process which shall ultimately result In cost cutting & improvement in efficiency.

- 9. **Delivery Schedule**: Firm have to supply the material i.e. Sulphuric Acid Tc of 40 MT (+/-5%) as per d elivery schedule given below:
- 1. 1st installment of 12.5% within 30 days from the date of issue of GeM contract.

- 2. 2nd installment of 12.5% within 60 days from the date of issue of GeM contract.

Note: The allowable periodic variation would be +/-5%. Under no circumstances, material will be acce pted beyond +5% allowed quantity tolerance. Any variation in periodic rate of supply more than -5% in each delivery schedule would be considered as delay in delivery and LD will be imposed on such short supply in which quantity is beyond -5% of each delivery.

- 10. **Quantity Tolerance:** The seller shall be allowed a tolerance of +/- 5% on the ordered quantity. Thi s tolerance is to simplify logistical constraints and accounting of material. If seller supplies quantity be yond tolerance limit (except quantity procure through option clause) then such material shall not be a ccepted and no payment shall be made for such supplies. Also if seller supplies less quantity than toler ance limit within stipulated delivery period then it shall be consider as supply shortfall.
