Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in

this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

# 5. Warranty Clause:

- 1. The supplier warrants that the goods supplied under the contract is new, unu sed, and incorporate all recent improvements in design and materials unless pr escribed otherwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as pe r SPMCIL's specifications) or workmanship or from any act or omission of the su pplier, that may develop under normal use of the supplied goods under the con ditions prevailing in India.
- 2. This warranty shall remain valid for twelve months after the goods or any por tion thereof as the case may be, have been delivered to the final destination and dinstalled and commissioned at the final destination and accepted by SPMCIL in terms of the contract.
- 3. In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- 4. Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/ goods thereafter.
- 5. In the event of any rectification of a defect or replacement of any defective g oods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPMCIL.
- 6. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPMCIL may have against the supplier.
- 6. **Anti-bribery clause**: By participating in this tender, the suppliers/Vendors /Contractors are deemed to have undertaken that they shall not give or take, an y financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident hap

pening, they shall report it to Vigilance.

# 7. GST Return:

Supplier should file the GST returns for outward supplies in time. In case of any I nput credit Loss to BNP by way of their failure to files GST returns in time, BNP r eserves the right to withhold the payment of further supplies till production of e vidence of filling of returns.".

# 8. <u>Liquidated Damages</u>:

If the supplier fails to deliver any or all of the goods or fails to perform the servic es within the time frame(s) incorporated in the contract, SPMCIL shall, without p rejudice to other rights and remedies available to SPMCIL under the contract, d educt from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

- 11. - **13.Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (re peat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qua lifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal do cuments proving such ownership.
- **14.Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Start-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), s ubject to their meeting the quality and technical specifications. - 3. QUALIFYING CONDITIONS for Non-MSE firms:-
- 3.1 Name of the customer / company where similar Compressors are installed.
- 3.2 Complete postal address of the customer.
- 3.3 Month & Year of commissioning.
- 3.4 Board specification of the machine (S).
- 3.5 Name and designation of the contact person of the customer.
- 3.6 Phone, FAX no. and e-mail address of the contact person of the customer.
- 3.7 "Performance certificate from the customer regarding satisfactory performance machine supplied to them (Original Certificate or Through E-mail directly fr
