- 1. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. #### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

NOTE: a. The scope of work uploaded in the Scope of Work as per Buye r's Requirement enclosed on Page 3 of the bid and also uploaded in the Buyer uploaded ATC document of the bid will supersede the technical s pecification of the bid under category.

b. The bidder shall strictly participate and quote as per the Scope Of Work As Per Buyer's Requirement enclosed on Page 3 of the bid and al so uploaded in the Buyer uploaded ATC document of the bid.

# I. Qualification and eligibility criteria of Bid

(I) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitte d.

(II) Goods & Service Tax Registration (GST): The Bidder should be registered with Goods & Service Ta x (GST). Relevant proof of registration Certificate shall be submitted.

#### (III) Undertaking:-

- a) The bidder has to provide the undertaking that "We M/s \_\_\_\_\_firm has not been blacklis ted by Government of India/PSU/Any Reputed Organization in the past".
- b) The bidder has to provide the undertaking that "We M/s. <Name of the firm>agree to wit hdraw all the deviations, if any, unconditionally and accept all the Terms and condit ions of the document including the technical specifications."
- c) The bidder has to provide the undertaking that "We M/s. <Name of the firm> have the C apability to execute the tendered services".
- **IV. Payment Terms: -** The payment will be made as per the actual number of empty Fire Extinguishers fil led, HPT Tested, Painted, Labelled, & Repaired after getting back to ISP along with HPT Test Certificate and Original Tax Invoice.
- **V. Period of contract:** The period of contract will be valid for 2 Months.
- **VI. Quantum of LD:**If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. Two days). If the bidder does not comply or respond by the date /period (i.e. within Two days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at t he initiative of the bidder shall be entertained.

**Note:** While submitting the Clarification/Shortfall Document any technical difficulty occurs on GeM portal, then the bidder can submit the Clarification / Shortfall Document through e-mail (e-mail id: <a href="mailto:purchase.isp@spmcil.com">purchase.isp@spmcil.com</a>).

The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall informatio n/ documents only in case of historical documents that pre-existed at the time of the Bid Opening, and whi ch have not undergone change since then and does not grant any undue advantage to any bidder. As far a s the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and considered.

For example, if the bidder has submitted a supply order without its completion/performance certificate, the certificate will be asked for and considered. However, no new supply order shall be asked for to qualify the bidder.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
