#### 2. Certificates

#### 2. Delivery Period:

Work to be started within 03 (THREE) days from the date of issue of contract & the contract shall remain v alid for twelve (12) months.

#### 3. Terms and Mode of payments:

Payment will be done on quarterly basis after receiving original invoice along with other necessary docum ents/service report and suitability by the user department of India Government Mint, Kolkata.

#### 4. Insurance:

The supplier shall make arrangements for insuring the goods and services against loss or damage, inciden tal to manufacture or acquisition, transportation, storage and delivery. The Supplier shall be responsible til I the entire goods contracted for arrive in good condition at destination. The transit risk in this respect shal I be covered by the supplier by getting the goods duly insured. The insurance cover shall be obtained by t he supplier in its own name not in the name of India Government Mint, Kolkata or its consignee. #### 5. Quantum of LD:

If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, depending on the position of the case, either the purchaser or the s upplier shall give notice to the other party of its intention to commence arbitration. When the contract is w ith domestic supplier, the applicable arbitration procedure will be as per Indian Arbitration and Conciliation Act, 1996 as amended by Arbitration and Conciliation (Amendment) Act, 2015 and 2021. Mode of settleme nt of such contractual disputes/ differences shall be through Arbitration, to the India International Arbitrati on Centre.

#### **19. Risk Purchase Clause :**
