Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. #### 3. Delivery Period:

a) The bidder is required to deliver the item/carry out the service within One Hundred Fifty(150) Days from the date of issue of Contract.

b) The bidder is responsible for delivering the material and duly unloading the same at the General Store of India Government Mint, Kolkata after taking necessary security clearance from CISF at the main gate of In dia Government Mint, Kolkata by showing the driving licence, vehicle registration etc. and necessary docu ments like invoice, delivery challan, copy of Purchase Order, e-way bill, bank details in company letter hea d duly sealed & signed etc. are to be handed over to Store- in- charge.

#### 5. Warranty:

(b) The Warranty shall remain valid for a period of **One (1) year from the date of acceptance by user section of India Govt.
