validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Experience and Past Performance above, would also be considered to be qualified provided: i) their for eign manufacturer who holds intellectual property rights, meets all the criteria above without exempti on, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. Iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.

- 3. For Authorized Representatives: Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meet s all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforc eable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligati ons as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for same set of se rvices as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 'The Relevant Date'.

  - (iii) Latest Udyam Certificate, if bidder is claiming any benefits against MSE Policy.
  - (iv) Audited Balance sheet & Profit and loss statement of FY 2021-22, FY2022-23 & FY 2023-24 dul y certified by Chartered Accountant/ Cost Accountant in India or equivalent in relevant countrie s.
  - (v) Declaration regarding local content with details of location at which value addition activity is b eing done, if bidder has applied for Make in India purchase preference.
  - (vi) Undertaking/Declaration certificate that you are currently not suspended/Banned/Blacklisted by any ministry/ department of govt. of India or by any state govt. for business dealing.
  - (vii) Compliance declaration regarding land border sharing clause in the format as above.

#### 13. Note for bidders:

- i. Along with all the necessary documents/ certificates required as per the bid conditions, the bid der should furnish a brief write-up, backed with adequate data, explaining his available capacity (both technical and financial), for manufacture and supply of the required goods/ equipment, wi thin the specified time of completion, after meeting all their current commitments.
- ii. Supporting documents submitted by the bidder must be certified as follows:

Anti-Bribery clause:** By participating in this tender, the suppliers/Vendors/Contractors are deeme d to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any su ch incident happening, they shall report it to Vigilance.

#### 15. Warrantee clause:

(a) The supplier warrants that the goods supplied under the contract is new, unused, and incorporate all recent improvements in design and m aterials unless prescribed otherwise by SPMCIL in the contract. The supplier further warrants that the goods supplied under the contract shall h

ave no defect arising from design, materials (except when the design a dopted and / or the material used are as per SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may deve lop under normal use of the supplied goods under the conditions prevail ing in India.

- **(b)** This warranty shall remain valid for twelve months after the goods or any portion thereof as the case may be, have been delivered to the fin all destination and installed and commissioned at the final destination and accepted by SPMCIL in terms of the contract.
- (c) In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- (d) Upon receipt of such notice, the supplier shall, with all reasonable s peed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPM CIL for such replaced parts/ goods thereafter.
- **(e)** In the event of any rectification of a defect or replacement of any de fective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months f rom the date such rectified / replaced goods starts functioning to the sa tisfaction of SPMCIL.
- **(f)** If the supplier, having been notified, fails to rectify/ replace the defe ct(s) within a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed f it by SPMCIL, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPMCIL may have against the supplier.
- **16. ZED & LEAN Certification**: Government of India has launched scheme for obtaining ZED & LEAN c ertification to MSE vendors. Accordingly bidders are requested to obtain these certification to ensure minimum wastage in production process which shall ultimately result In cost cutting & improvement in efficiency.
