9. TECHNICAL REQUIREMENTS FOR "Construction of Badminton Hall for ISP and CNP in the township premises of India Security Press, Nashik Road.":

Scope of the work: Brief requirement of Construction of Badminton Hall for ISP and CNP in the township premises of India Security Press, Nashik Road is given as below:

The proposed/indicative scope of work shall include, but not be limited to, the following:

1. Site Assessment

(A) Conducting site surveys for assessing leveling and grading of the site and accordingly finalizing the required dimensions.

2. Design and Engineering

(A) Preparation of architectural, structural drawings and related Electrical, Plumbing, drainage, storm water and sewer drain designs.

(B) Integration of space planning for playing areas, changing rooms, toilets and allied facilities.

3. Civil Construction

(A) Construction of foundations, superstructure, and suitable roofing system as per requisite standards of badminton hall (such PEB or as required).



(B) Erection of steel trusses or appropriate structural framework.

- (C) Construction of internal partitions, walls and cladding works.
- 4. Interior Works and Sports Infrastructure

(A) Provision and installation of professional-grade badminton flooring court line markings as per guidelines.

(B) Installation of court equipment, with marking of Courts (posts, nets, floor markings etc.).

(C) Construction of changing rooms, toilets, shower facilities, and administrative spaces.

- 5. Electrical and Lighting Works
 - (A) Electrical distribution system including panels and wiring.
 - (B) Installation of high-lux LED sports lighting appropriate for indoor play.
- 6. Plumbing, and Ventilation
 - (A) Installation of ventilation systems
 - (B) Plumbing systems including water supply, drainage, and sanitary fittings.
 - (C) Rainwater drainage and harvesting provisions (if applicable).
- 7. External Works and Site Development
 - (A) Landscaping, parking areas, fencing/boundary wall.
 - (B) Pathways, signage, and outdoor lighting.
 - (C) Stormwater drainage and utility connections.
- 8. Preliminary cum detailed Estimation

(A) The firm shall submit the Preliminary cum detailed Estimation covering different heads of the scope of the work, with all required technical details as listed above.

9. Pre-Qualification Criteria:

- (a) The details of work executed of similar type of **"Civil work"** by them during last seven years ending on 31.03.2024.
- (b) The firm should confirm their annual capacity for Execution of similar type of "Civil work"
- (c) The documents in support of Expression of Interest need to be submitted duly signed by authorized representative of the company.
- (d) The bidders should give a declaration that they have not been blacklisted or debarred for dealing by Government of India or any Government / PSU/ Reputed organisation in the past.
- (e) The interested bidders should also submit along with Expression of Interest a list of parties to whom they have executed similar type of "**Civil work**" with details and performance report from their clients.
- (f) The interested bidder should also submit copies of audited financial documents for the financial year 2021-22, 2022-23 and 2023-24.

10. The bidder should also confirm specifically that:

(a) The bidder should provide details of enlistment in either Central Public Works Department (CPWD) or Military Engineering Services (MES) or any other Government /PSU / Autonomous bodies.
