Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid: -

I) Experience and Past Performance: - The Bidder should have Supplied, In stalled, Tested, commissioned at least one number of Compressed Air Pipeline with same or higher specification in the last five years ending on 31.03.2024. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

Note: i) Copies of PO's and completion/experience certificates issued by custo mers to be provided in support of above.

- ii) Start-ups and Micro and small Enterprises are exempted from Experience a nd Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his e ligibility for exemption must be submitted for evaluation.
- II) Capability-Equipment & Manufacturing Facilities: The bidder firm mus

t have an annual capacity to manufacture and supply at least one "Compresse d Air Pipeline".

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidder / fabricator firm(s) might be undertaken by a Committee o r through a third party Technical Consultancy / Inspection agencies to ensure th at the firm is/are identified and capable to supply the machine/item/material/pr oduct as required.

III) Financial Standing: -

- a) The Average annual financial turnover of the bidder during the last three yea rs, ending on 31.03.2024 should be at least Rs. 31,51,444/- as per the annual r eport (audited balance sheet and profit & loss account of FY 2021-22, 2022-23 & 2023-24) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India or equivalent in relevant countries.
- i) The net worth of the Bidder should not be negative on 31.03.2024 and also
- ii) should not have eroded by more than 30% in the last three years, ending on 31.03.2024.
- Note 1: To ascertain this criteria net worth of initial and last financial year should be compared.
- Note 2: For MSEs and Start-ups (registered for the tendered item) all f inancial criteria shall be exempted.
- **IV) For Existing successful Past Suppliers:** In case the bidder (manufactur er or principal of authorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as noti fied by Government of India from time to time.)
- **V) Joint Ventures and Holding Companies:** Credentials of the partners of J oint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **VI) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.
- VII) Goods & Service Tax Registration (GST): The Bidder should be registe red with Goods & Service Tax (GST). Relevant proof of registration Certificate s hall be submitted.

X) Note:

- a) The Indian agent on behalf of the Principal/ OEM or principal/OEM itself can b id but both cannot bid simultaneously for the same item/ product in the same B id. - e) Bidders may please note that GeM is capturing and showing the IP addresses used by the bidder(s). The received bids having matching / common IP address with bidder(s), shall be outrightly rejected & shall not be considered for further evaluation.
- f) Request for extension of the bid opening date and / or any other query relate d to bid should be made through GeM portal only, no other means of communic ation will be entertained.
- **XI) Delivery Schedule: -** The firm on whom contract will be placed will have to complete the SITC within 120 Days from the date of contract.
- **XIV) Warranty: -** The party / bidder shall warranty / guarantee the material an d workmanship of the entire system for at least One year from the date of commissioning and final acceptance.
- XV) Quantum of LD:- If the Seller/Service Provider fails to deliver any or all of

the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

XVI) Payment Terms: - 100% on receipt and acceptance of goods by the con signee and on production of all required documents by the supplier.

XVII) Ministry of Finance, Department of Expenditure, Public Procurem ent Division, Orders (Public Procurement 1,2 and 3) F. No. 6/18/2019-P PD dated 23rd/ 24th July 2020 (or any further amendments thereof) re garding eligibility of bidders from specified countries shall be applicable to this tender. - iv) An Indian (or other) agent of such an entity; or
- v) A natural person who is a citizen of such a country; or
- vi) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
- e) The beneficial owner for the purpose of (III) above will be as under:
- i) In case of a company or Limited Liability Partnership, the beneficial owner is t he natural person(s), who, whether acting alone or together, or through one or more judicial person, has a controlling ownership interest or who exercise contr ol through other means.
- ii) Explanation:
- (1) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.
- (2) In case of a partnership firm, the beneficial owner is the natural person(s) w ho, whether acting alone or together, or through one or more juridical person, h as ownership of entitlement to more than fifteen percent of Capital or profits of the partnership.
- (3) In case of an unincorporated association or body of individuals, the benefici allowner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the bene ficial owner is the relevant natural person who holds the position of senior man aging official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fiftee n percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership
- (vi)An Agent is a person employed to do any act for another, or to represent an other in dealings with third person.

XVIII) Note regarding MSE and MII purchase preference:

For MSE Purchase Preference:

Instant bid is non-splitable / non-dividable in nature. Therefore, in case L1 is no n-MSE then MSE firm quoting price within L1+15% band will be awarded full ten dered quantity subject to matching the L1 prices.

For MII Purchase Preference:

For goods and works where the requirements are not divisible in nature

- a) Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-I I ocal supplier', the contract will be awarded to L1.
- b) If L1 is not 'Class-I local supplier' the lowest bidder among the 'Class -I local supplier', will be invited to match the L1 price subject to Class-I local supplier's quoted price falling within the margin of purchase preference i.e. L1+20% band , and the contract shall be awarded to such 'Class-I local supplier' subject to ma tching the L1 price.
- c) In case such lowest eligible 'Class-I local supplier' fails to match the L1 price, the 'Class-I local supplier' with the next higher bid within the margin of purchas e preference i.e. L1+20% shall be invited to match the L1 price and so on and c ontract shall be awarded accordingly. In case none of the 'Class-I local supplier' within the margin of purchase preference matches the L1 price, the contract m ay be awarded to the L1 bidder.
- **XIX) Clarification of Bids/Shortfall Documents:** During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on G eM portal, asking the bidder to respond by a specified date/period (i.e. Seven d ays). If the bidder does not comply or respond by the date/period (i.e. within Se ven days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.
