Section II: Technical Specification

Visit of OEM's Services engineer to rectify mechanical issues and fine tuning of both Rapida Machines.

Service Engineer has to attend KBA Rapida 105 Machines for four days.

Following issues have been observed on machine from mechanical side.

Service engineer has to attend all these issues.

1. Image Doubling/ Blurring
2. Incorrect Cylinder Pressure Settings Plate, Blanket and impression cylinder pressures/ dial settings need to be properly calibrated. Excessing packing is currently required, which is not ideal. Requesting your assistant to reset the correct pressure settings.
3. Side Lay Malfunction: Side lays on both machines are malfunctioning. The paper pulling function is inaccurate, causing intermittent variation. Please check and rectify.
4. Ink Leakage from Ducts: Persistent ink leakage has been observed from the ink ducts of both machines. Request inspection and sealing/ fixing of the leakage points.
5. Delivery Pile Paper Locking- Machine No. 2: At the delivery pile of Machine No. 2, paper locking issues persists. The static eliminator and side joggers may require repair. Additionally, gripper and delivery cam settings, along with synchronization at variable speed, need to be checked.
6. Plate Clamping Bar issues: The plate clamping bars on both machines are not functioning correctly.
