Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.
- 2. Buyer Added text based ATC clauses

NOTE 1: Bidders must refer The Corrigendum Document attached in "Buyer Added Bid Specific ATC Document" of Bid & strictly participate as per terms and conditions of GeM Bid & Corrigendum issued.

NOTE2: The Technical Specification and Scope of work enclosed with bid documents in "Buyer Uploaded ATC Document" will supersede all the parameters selected. Accordingly, before quoting bidders are requested to go through enclosed Technical Specification and Scope of work and bid accordingly.

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

I) Experience and Past Performance: -

The bidder (manufacturer or principal of authorized representative – hereinafter referred simply as 'The Bi dder') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned Screw compressor with the same or higher specifications of at least one number in last five years ending on 31.03.2024. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

Note: i) Copies of PO's and completion/experience certificates issued by customers to be provided in support of above.

ii) Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting do cuments to prove his eligibility for exemption must be submitted for evaluation.

II) Capability-Equipment & Manufacturing Facilities: The bidder firm must have an annual capacity to Supply, Install, Test, Commission at least one number of Screw compressor with the same or higher spe cifications as enclosed in GeM bid.

III) Financial Standing: -

- a) The Average annual financial turnover of the bidder during the last three years, ending on 31.03.2024 s hould be at least Rs. 28,04,000.00/- as per the annual report (audited balance sheet and profit & loss account of FY 2021-22, 2022-23 & 2023-24) of the relevant period, duly authenticated by a Chartered Account ant/Cost Accountant in India or equivalent in relevant countries.
- i) The net worth of the Bidder should not be negative on 31.03.2024 and also
- ii) should not have eroded by more than 30% in the last three years, ending on 31.03.2024.
- Note 1: To ascertain this criteria net worth of initial and last financial year should be compare d.
- Note 2: For MSEs and Start-ups (registered for the tendered item) all financial criteria shall be exempted.
- **IV)** For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of 'Screw compressor' in at least one of the recent past t hree procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **V) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repe at cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each part ner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only on e of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **VI) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitt ed.
- **VII) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

VIII) Manufacturer's authorization letter:

Manufacturer's Authorisation Letter:

- a) Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certifica te with OEM/Original Service Provider details such as name, designation, address, email Id and Phone No. required to be furnished along with the bid.
- b) In case the bidder firm/ Bidder offers to supply of the Screw compressor which is manufactured by som e other firm, the Bidder has to be duly authorized by the manufacturer of the stated plant to quote for and supply and install the same to India Security Press, a unit of SPMCIL.

- **XIII) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- **XIV) Payment Terms: -** 100% on receipt and acceptance of goods by the consignee and on production of all required documents by the supplier.
- XV) Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23 rd/ 24th July 2020 (or any further a mendments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. - ii) An entity substantially controlled through entities incorporated, established or registered in such a country; or

- iv) An Indian (or other) agent of such an entity; or
- v) A natural person who is a citizen of such a country; or
- vi) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.

- i) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more judicial person, has a controlling ownership inte rest or who exercise control through other means.
- ii) Explanation:
- (1) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.
- (2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone o r together, or through one or more juridical person, has ownership of entitlement to more than fifteen per cent of Capital or profits of the partnership.
- (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural pers on(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of th e trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natur al person exercising ultimate effective control over the trust through a chain of control or ownership
- (vi)An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
- **XVI)** Clarification of Bids/Shortfall Documents: During the evaluation and comparison of bids, the pur chaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. Seven days). If the bidder does not comply or respond by the date/period (i.e. within Seven days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at

the initiative of the bidder shall be entertained.

The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall information/ documents only in case of historical documents that pre-existed at the time of the Bid Openi ng, and which have not undergone change since then and does not grant any undue advantage to any bid der. As far as the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and considered.

For example, if the bidder has submitted a supply order without its completion/performance certificate, the certificate will be asked for and considered. However, no new supply order shall be asked for to qualify the bidder.
