Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.
- 2. Buyer Added text based ATC clauses

NOTE 1: Bidders must refer The Corrigendum Document attached in "Buyer Added Bid Specific ATC Document" of Bid & strictly participate as per terms and conditions of GeM Bid & Corrigendum issued.

NOTE 2: Bidders are requested to submit Duly sealed and signed copy corrigendum issued Enclosed in "Buyer Added Bid Specific ATC Document" of Bid.

Buyer Added Bid Specific ATC

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid: -

- I) For MSE/Start-up firm: Capability Equipment & Manufacturing Facilities: The bidder firm sho uld have capability to manufacture and supply of similar kind of 'Parallel Cam Index Drives' as per attache d technical specifications.
- **II)** For other firm Experience and past performance: The bidder firm may be Manufacturer/Proven supplier/Authorized dealer or distributor of tendered item or bidder may participate with manufacturing a uthorization form (issued by manufacturer of tendered item).

Note: Participating bidder needs to submit all related documents along with the bid. In case, bidder is ma nufacturer/Proven Supplier/Authorized dealer or distributor of tendered item, then bidder has to submit rel evant document for the same. In case, bidder is not manufacturer/Proven Supplier/Authorized dealer or dis tributor of tendered item, then bidder has to submit manufacturing authorization form (issued by manufacturer of tendered item).

- **III) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three p rocurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- IV) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repe

at cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each part ner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only on e of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

- **V) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitte d.
- **VI) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service T ax (GST). Relevant proof of registration Certificate shall be submitted.

VII) Undertaking:-

VIII) Note:

- a) The Indian agent on behalf of the Principal/ OEM or principal/OEM itself can bid but both cannot bid sim ultaneously for the same item/ product in the same Bid. If an agent submits bid on behalf of the Principal/ OEM, the same agent shall not submit a bid on behalf of another Principal/ OEM in the same Bid for the same item.
- b) Interested firms are requested to submit the above required documents sealed and signed on al I page s along with Bid.
- c) Bidders may please note that GeM is capturing and showing the IP addresses used by the bidder(s). The received bids having matching / common IP address with bidder(s), shall be outrightly rejected & shall not be considered for further evaluation.
- d) Request for extension of the bid opening date and / or any other query related to bid should be made th rough GeM portal only, no other means of communication will be entertained.
- e) "Anti-Bribery Management System (ABMS): By participating in this tender, the suppliers/Vendors/ Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they n otice any such incident happening, they shall report it to Vigilance."
- IX) Delivery Schedule: Within 60 days from the date of issue of Contract.
- **X) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within t he original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recove r the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- **XII) Payment Terms:** 100% payment will be released within 30 days of receipt and acceptance of good s by the consignee and on production of all required documents by the supplier.
- **XIII) Warranty: -** Warranty required 1 Year from date of last supply/delivery of material & acceptance of the goods by ISP.

XIV)Manufacturer's authorization letter:

- a) Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certifica te with OEM/Original Service Provider details such as name, designation, address, email Id and Phone No. required to be furnished along with the bid.
- b) In case the bidder firm/ Bidder offers to supply of the parallel cam index drives which is manufactured by some other firm, the Bidder has to be duly authorized by the manufacturer of the stated plant to quote for and supply and install the same to India Security Press, a unit of SPMCIL.
- c) One manufacturer can participate through one authorized agent or one agent can participate on behalf

of one Principal Manufacturer only.

XV) Note regarding MSE and MII purchase preference:

For MSE Purchase Preference:

Instant bid is non-splitable / non-dividable in nature. Therefore, in case L1 is non-MSE then MSE firm quoti ng price within L1+15% band will be awarded full tendered quantity subject to matching the L1 prices.

For MII Purchase Preference:

For goods and works where the requirements are not divisible in nature

- a) Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-I local supplier', the contract will be awarded to L1.
- b) If L1 is not 'Class-I local supplier' the lowest bidder among the 'Class -I local supplier', will be invited to match the L1 price subject to Class-I local supplier's quoted price falling within the margin of purchase pr eference i.e. L1+20% band, and the contract shall be awarded to such 'Class-I local supplier' subject to m atching the L1 price.
- c) In case such lowest eligible 'Class-I local supplier' fails to match the L1 price, the 'Class-I local supplier' with the next higher bid within the margin of purchase preference i.e. L1+20% shall be invited to match the L1 price and so on and contract shall be awarded accordingly. In case none of the 'Class-I local supplier' within the margin of purchase preference matches the L1 price, the contract may be awarded to the L1 bidder.

XVI) Clarification of Bids/Shortfall Documents: During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. Three days). If the bidder does not comply or respond by the date/period (i.e. within Three days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.

Note: While submitting the Clarification/Shortfall Document any technical difficulty occurs on GeM portal, then the bidder can submit the Clarification / Shortfall Document through e-mail (e-mail id: purchase.isp@spmcil.com).

The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall information/ documents only in case of historical documents that pre-existed at the time of the Bid Opening, and which have not undergone change since then and does not grant any undue advantage to any bid der. As far as the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and considered.

For example, if the bidder has submitted a supply order without its completion/performance certificate, the certificate will be asked for and considered. However, no new supply order shall be asked for to qualify the bidder.

- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.
