- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 4. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- (I) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.
- (II) Goods & Service Tax Registration (GST): The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

(III) Undertaking:-

- a) The bidder has to provide the undertaking that "We M/s. have not been blacklisted by Government of India /PSU/Reputed Organization in the Past.".
- b) The bidder has to provide the undertaking that "We M/s. agree to withdraw all the devi ations, if any, unconditionally and accept all the Terms and conditions of the bid docum ent including the technical specifications."
- c) The bidder has to provide the undertaking that "We M/s. have the Capability to supply of the tendered item i.e. Poly propylene Transparent Film Band Roll".

- d) Bidders are requested to supply GeM Contracts/ Purchase for tender item i.e. Band Roll for verification of capability along with the undertaking as mentioned above.
- (IV) Delivery Schedule: Within 60 days from the date of issue of Contract.
- **(V) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Servi ces within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be en titled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Ma jeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- **(VI) Payment Terms: -** Payment will be released within thirty (30) days of issue of Consignee Receipt-cum Acceptance Certificate (CRAC) and submission of bills.

VIII) Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement (To be submitted on firm's Letter Head as a token of acceptance): -

- **1) Pre-Production Sample: -** The qualifying firm has to supply 1 rolls each of 60 mm and 40 mm as sample roll for suitability test within 20 days from the date of issuing Purchase Order b efore bulk supply.
- **2) Bulk Supply-** Balance quantity i.e, 299 rolls each of Band roll 40 mm and 60 mm is to be s upplied after receiving suitability of pre-production sample from ISP. However, the entire supply has to be completed within 60 days from date of Purchase Order.
- **3)** The delivery schedule may be pre-pond or post-pond as per the indent and accordingly provision of the same may be mentioned in tender.

4) Quality Control Requirement: -

- (i) The material supplied by the successful bidder will be accepted on all parameters as per spe cification provided in the Bid Document. The purchaser reserves the right to get the material s upplied tested from in-house laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.
- (ii) After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is n oticed then the same will be re-placed free of cost by the supplier/seller up to India Security Pr ess, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

IX) Special Conditions of Contract (SCC)

1) Transportation of Goods: The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price b id of the item to be procured.

- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis the refore the cost of the insurance will also the part of the cost of the material borne by the suppli er. A specific insurance cover for each consignment/supply is to be given by firm, as applicable
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier s hall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.
- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies e tc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include tax es and duties asper law of the land in the tender, no claim thereof will be considered by purcha ser at a later stage.
- **5) Terms and Mode of Payment:** 100% payment will be released within thirty (30) days of i ssue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. T he payment will be done through online mode only. Therefore, the suppliers have to produce a ll the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.
- **6) Termination/Short Close of Contract:** India Security Press, Nashik reserves the right to t erminate the contract, in whole or in part for ISP's convenience, by serving written notice on the supplier at any time during the currency of contract.

Clarification of Bids/Shortfall Documents: During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. If the bidder does not comply or respond by the date/period (i.e. wit hin three days), his tender will be liable to be rejected. Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.

The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall inf ormation/ documents only in case of historical documents that pre-existed at the time of the Bid O pening, and which have not undergone change since then and does not grant any undue advanta ge to any bidder. As far as the submission of documents is concerned regarding qualification criter ia, after submission of the bid, only related shortfall documents shall be asked for and considered. For example, if the bidder has submitted a supply order without its completion/performance certificate, the certificate will be asked for and considered. However, no new supply order shall be asked for to qualify the bidder.
