Scope of the work: Brief requirement of Advanced High Resolution Video Spectral Comparator is given as below:

Brief Requirement for advanced higher resolution “Video Spectral Comparator”

1. Scope of Work: For examination of questioned security documents namely e Passports, Judicial Stamp Papers, Postage Stamps, Cheques, Holographic Images and all type of security documents which have been printed in ISP.
2. Basic Feature of the Comparator: The Comparator shall be suitable for scientific examination of high-level forgery suspected documents being receive from various law enforcement agencies, with extensive facilities for analyses and documentation.
3. Product Configuration: Capable for examination of documents printed with high resolution security designs.
 - a) High resolution camera and its magnification
 - b) Field of view, X-Y stage
 - c) Camera filters
 - d) Illumination system

- e) Micro spectrometer
- f) OCR MRZ and CARD reader
- g) RFID Reader for e Passport
- h) System Software features and software updates
- i) Calibration and Diagnostics
- j) Computer and Monitor

ESSENTIAL TERMS AND CONDITIONS:

- a. The firm shall undertake to provide after sales service for minimum 10(ten) years from the date of the acceptance of the system, as and when required.
- b. The firm shall ensure to provide support for supply of spare parts for the machine for the period of ten years from the date of FAC as and when ordered, and these shall be compatible/ directly replaceable spare parts.

SAFETY AND PRODUCT STANDARD: The entire instrument / system shall conform to international standards and ICAO guidelines and applicable strength besides safety regulations/guidelines. The certificate of same should be produced along with supply.

1. Pre-Qualification Criteria:
