If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

3. Undertaking: -

Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- **5. Payment Terms: -** Payment will be released within thirty (30) days of issue of Consignee Receipt-cum A cceptance Certificate (CRAC) and submission of bills.
- **6. Anti-Bribery Management System (ABMS):** By participating in this tender, the suppliers'/Vendors/ Co ntractors are deemed to have undertaken that they shall not give or take, any financial or n on-financial br ibe, to or from anyone during the tender or during the execution of the contract thereafter and if they notic e any such incident happening, they shall report it to Vigilance."

- 8. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement (To be submitted on firm's Letter Head as a token of acceptance):
 - **a. Pre-Dispatch Sample:** A Sample of 1 Kg is to be submitted free of cost for approval, b efore bulk Supply. Sample must be submitted within 15 days of issue of GeM contract date and within 15 days suitability status shall be confirmed.
 - b. Delivery Schedule:
 - i. 1st lot of 250 Kg within 60 days from the date of acceptance of sample.
 - ii. 2nd lot 250 Kg within 90 days from the date of acceptance of sample.
 - c. Quality Control Requirement:
 - i. The material supplied by the successful bidder will be accepted on all pa rameters as per specification provided in the Bid Document. The purchaser reserves the right to get the material supplied tested from in-house laboratory or a ny other laboratory of repute and in case the material is found not meeting the spe

cification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.

ii. After receipt of goods, the goods will be inspected/tested at ISP. If any de fect/variation is noticed then the same will be replaced free of cost by the supplier/seller up to India Security Press, Nashik Road, failing which equivalent amount of d efective material will be deducted in the subsequent bills or from any amount due to them.

9. Special Conditions of Contract (SCC):

- **a.** Transportation of Goods: The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.
- **b.** Insurance: Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis th erefore the cost of the insurance will also the part of the cost of the material borne by the s upplier. A specific insurance cover for each consignment/supply is to be given by firm, as a pplicable.
- c. Distribution of Dispatch Documents for Clearance/Receipt of Goods: The supplier shall se nd all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.
- **d.** Taxes and Duties: Supplier shall be entirely responsible for all taxes, duties, fees, levies e tc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered b y purchaser at a later stage.
- **e.** Termination/Short Close of Contract: India Security Press, Nashik reserves the right to ter minate the contract, in whole or in part for ISP's Convenience, by serving written notice on the supplier at any time during the currency of contract.

10. Important Note:

- **a.** All experience, past performance and capacity/ capability related/ data (as applicable) sh ould be certified by the authorized signatory of the bidder firm.
- **b.** Decision on Finalization of tender will be taken based on the documents submitted along with the tender. All documents must be submitted as per tender requirement failing which offers will be liable for rejection.
- **c.** All the pages submitted are to be sealed & signed by Authorised Signatory failing which t ender shall be treated as unresponsive.
- **d.** Bidders may please note that GeM is capturing and showing the <u>IP addresses</u> used by th e bidder(s). The received bids having matching / common IP address with bidder(s), shall b e outrightly rejected & shall not be considered for further evaluation.
- e. Request for extension of the bid opening date and / or any other query related to bid s hould be made through GeM portal only, no other means of communication will be entertained.

f. Clarification of Bids/Shortfall Documents:

- **i.** During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification s hall be sought only once on GeM portal, asking the bidder to respond by a specifie d date/period (i.e. Three days). If the bidder does not comply or respond by the dat e/period (i.e. within Three days), his tender will be liable to be rejected.
- **ii.** Depending on the outcome, such bids are to be ignored or considered fur ther. No post-bid clarification at the initiative of the bidder shall be entertained.
- **iii.** Note: While submitting the Clarification/Shortfall Document any technical difficulty occurs on GeM portal, then the bidder can submit the Clarification / Shortf all Document through email (e-mail id: purchase.isp@spmcil.com).
- **iv.** The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall information/ documents only in case of historical documents that pre-existed at the time of the Bid Opening, and which have not undergone change since then and does not grant any undue advantage to any bidder. As far as the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and consider ed.

For example, if the bidder has submitted a supply order without its completion/perf ormance certificate, the certificate will be asked for and considered. However, no n ew supply order shall be asked for to qualify the bidder.

- g. Representation against the Technically Rejected Bidders in GeM: With respect to the representation window for rejected bidders, any clarification/shortfall document submit ted in the representation window will not be accepted. Only a representation about the wro ng evaluation done will be considered.
