Quantum of LD: If the Seller/Service Provider fails to deliver any or all of the Goods/S ervices within the original/re-fixed delivery period (s) specified in the contract, the Bu yer will be entitled to deduct/recover the Liquidated Damages for the delay, unless co vered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damage s not exceeding 10% of the contract value of delayed quantity without any controvers y/ dispute of any sort whatsoever.

Clarification of Bids/Shortfall Documents:

During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, a

sking the bidder to respond by a specified date/period (i.e. Seven days). If the bidder does not c omply or respond by the date/period (i.e. within Seven days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.
