### **13. General requirements:**

- i. Auto feeding the loaded sheets for printing.
- ii. Machine should be equipped with suitable software for printing different variety of jobs in multiple colours with QR code, document number, photograph, etc on different types of substrates (both coated and uncoated).
- iii. Latest version of software to be provided with fault indication and diagnostic and corrective remedial measures.
- iv. Machine should be equipped with all additional accessories (including compressor if required).
- v. Machine should have proper exhaust system to avoid fumes generated/ accumulated at worksite.
- vi. The supplier should give warranty with free service for a period of 12 (twelve) months after completion of installation, commissioning, testing of the machine.

### **14. Pre-Qualification Criteria:**

- (a) The bidders should give a declaration that they have not been blacklisted or debarred for dealing by Government of India or any Government / PSU/ Reputed organisation in the past.  
*(“We M/s \_\_\_\_\_ firm has not been blacklisted by Government of India/PSU/Any reputed organization in the past”)*
- (b) The documents in support of Expression of Interest (EOI) need to be submitted **Duly Signed by Authorized Representative** of the company.
- (c) The bidder shall be a manufacturer of Digital production system for at least last three years and supplied & commissioned Digital production system with compatible processing software to print wide variety of substrates or media with the same or higher specifications of at least one number in last three years ending on “31.03.2025”. At least one number of the product offered for supply should be in successful operation for at least one year on the date of EOI opening. The bidder should provide the documentary evidence for the same.
- (d) The interested bidders shall also submit copies of Audited financial statement (Audited Balance Sheet and Profit & Loss Account) for the last Five (05) years i.e. 2020-2021, 2021-2022, 2022-2023, 2023-2024 & 2024-2025.

**15.** The bidder should also confirm specifically that:

- (a)** Applicant is competent and legally authorized to submit and/ or to enter into legally binding contract.
- (b)** The firm should confirm their annual installed capacity for Digital production system compatible processing software to print wide variety of substrates or media.
- (c)** Applicant will absolve the purchaser against any infringement of patent rights and other contract provisions.
