7. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;



(4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.

(5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership

3. Transparency :95% or more.
4. Length per roll : 1000 meters
5. Core Dimension : Standard
6. Shrink temperature : The film should shrink between Temperature 150-200°C on a running shrink pack machine.

**1. Pre- Dispatch Sample:** - A Sample of 01 Roll is to be submitted free of cost for approval, before bulk Supply. Sample must be submitted within 30 days of issue of GeM contract date and within 15 days suitability status shall be confirmed.

**2. Delivery Schedule:** - After acceptance of sample.

- 1st lot 125 Rolls within 60 days from the date of issue of Supply order / GeM Contract.
- 2nd lot 125 Rolls within 120 days from the date of issue of Supply order / GeM Contract.
- 3rd lot 125 Rolls within 180 days from the date of issue of Supply order / GeM Contract.
- 4th lot 125 Rolls within 240 days from the date of issue of Supply order / GeM Contract.
- 5th lot 125 Rolls within 300 days from the date of issue of Supply order / GeM Contract.
- 6th lot 125 Rolls within 330 days from the date of issue of Supply order / GeM Contract.

### **3. Quality Control Requirement: -**

- i. The material supplied by the successful bidder will be accepted on manufacturer's test report/COA of all parameters as per specification provided in the Bid Document. The supplier has to provide test certificate containing all parameters as per ISP specification along with each supply. The purchaser reserves the right to get the material supplied and tested from in house laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.
- ii. After receipt of goods, the goods will be inspected /tested for performance at ISP. If any defect/variation is noticed then the same will be replaced free of cost by the supplier/seller up to India Security Press, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

### **XIII) Special Condition of Contract (SCC):**

**1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.

**2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore the cost of the insurance will also be the part of the cost of the material borne by the supplier. A specific insurance cover for each consignment/supply is to be given by firm, as applicable.

**3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier shall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.

**4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

**5) Terms and Mode of Payment:** 100% payment will be released within thirty (30) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.

**6) Termination/Short Close of Contract:** India Security Press, Nashik reserves the right to terminate the contract, in whole or in part for ISP's convenience, by serving written notice on the supplier at any time during the currency of contract.

### **7) NOTE:**

- i. All experience, past performance and capacity/ capability related/ data should be certified by the authorized signatory of the bidder firm.
- ii. Decision on Finalization of tender will be taken based on the documents submitted along with the tender. All documents must be submitted as per tender requirement failing which offers will be liable for rejection.
- iii. All the pages submitted are to be sealed & signed by Authorized Signatory failing which tender shall be treated as unresponsive.

If the bidder does not comply or respond by the date/period (i.e. within three days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.

As far as the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and considered.
