VI. **Scope of Work-**

i. Loading the gunny bundles in dept. vehicle from in front of Female Section, shifting and proper stacking inside Moha Godown on daily basis to keep platform free from such waste paper cutting bundles.

ii. Additionally, shifting the waste paper cutting bundles strewn across ex-GCD area, behind ISP Stores and many such areas, to inside Moha Godown in dept. vehicle.

iii. Shifting and stacking of scrap corrugated boxes strewn across the ex-GCD area, behind ISP Stores and many such areas to inside Bailing section.

iv. Segregation and stacking of all scrap materials at its designated place.

The proportionate amount may be deducted for the absence of the Unskilled labours.

**VIII. Quantum of LD:** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period (s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/ dispute of any sort whatsoever.
