The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (**i.e. seven days**). If the bidder does not comply or respond by the date/period (**i.e. within seven days**), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.
