The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 3) Vehicle: The Goods Truck (Medium Commercial Vehicle, MCV) 6-wheeler of make Tata or Eicher or equivalent must have of min. 10 Ton payload capacity and must have capability to be used for above mentioned scope of work and the pickup vehicle shall be utility vehicle Double cabin Pick up AC vehicle of make Camper or Yodha or equivalent. Product catalogue of to be given vehicle to ISP must be enclosed by bidder at the time of bidding.

4) Duty Timings: The vehicle required for 24 Hours at India Security Press, Nashik.

5) The fuel (High Speed Diesel) shall be provided by India Security Press, Nashik. The running maintenance / Breakdown repairs, Oiling and greasing shall be responsibility of contractor or of the vehicle.

6) Registration of vehicle, fitness, Compressive Insurance, Pollution certificate, RTO Document and other required document will be maintained by the bidder.

7) Any compensation on account of accident or damage to the vehicle or for death of any third party / ISP employee or injury or loss should be covered under terms and condition of insurance and the same should be ensured by the contractor, no liability towards ISP.

ct, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/ dispute of any sort whatsoever.

Clarification of Bids/Shortfall Documents:
