6. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for % (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
7. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. To appoint a professional Source Code Escrow Service Provider for secure custody in India, indep

endent verification, maintenance, and controlled release of application source code and associated documentation pertaining to the software supplied by software owner i.e. Depositor/Seller, in order to safeguard the interests of BENEFICIARY i.e. ISP/SPMCIL and ensure business continuity throughout the contract period.

2. Scope of Services

The Escrow Service Provider shall provide end-to-end source code escrow services, including secure deposit management, source code verification, update management, reporting, and release administration. The Escrow Service Provider should be ISO 270001 certified and should ensure the compliance of Information Security framework.

2.1 Establishment of Escrow Account

The Service Provider shall:

a) Execute a tripartite Source Code Escrow Agreement among:

- Beneficiary i.e. ISP
- Depositor i.e. Software owner
- Escrow Service Provider (Escrow Agent)

b) Establish and administer a secure escrow account for deposit and storage of source code and related materials.

c) Define and document escrow procedures, release conditions, rights, obligations, and responsibilities of all parties.

2.2 Initial Deposit Management

The Service Provider shall receive and securely maintain the following items from the Depositor:

- Complete application source code.
- Build scripts and configuration files.
- Database schemas and scripts.
- Libraries, dependencies, and third-party components required for compilation.
- Installation and deployment documentation.
- Technical and system architecture documents.
- User manuals and maintenance documentation.
- Any additional materials/documents required to build, deploy, operate, and maintain the software.

2.3 .Source Code Verification and Build Validation

The Service Provider shall perform independent verification of the deposited materials to confirm their completeness and usability on every deposit.

Verification activities shall include:

a) Inventory Verification

- Verification of deposited files against the submitted inventory.
- Confirmation of completeness of source code and supporting documentation against agreed specification.
- Service Provider shall discover if any of the Deposit Materials are encrypted, or password protected or to provide de-encryption tools/keys, passwords or information needed for decryption and inform to Beneficiary.

b) Technical Verification

- Examination of source code structure and associated components.

- Verification of presence of required build tools, scripts, and dependencies.

c) Build Verification

- Compilation/build of the deposited source code in a controlled environment.
- Generation of verified executable files with hash-based integrity validation, binaries, or deployable packages/executables.
- Validation that the build process completes successfully (check full build log).
- Verification that generated outputs correspond to the deposited software version.

d) Verification Reporting

- Submission of a detailed Source Code Verification Report and Inventory Report to Beneficiary.
- Identification of deficiencies, missing files, inconsistencies, or build failures, if any.
- Follow-up verification after rectification by the Depositor.

2.4 Periodic Updates and Version Management

The Service Provider shall:

a) Accept periodic source code updates from the Depositor whenever:

- Software upgrades are released.
- New versions are deployed.
- Major patches or enhancements are implemented.

b) Maintain version history and audit trail of all deposits.

c) Verify receipt and integrity of updated deposits.

d) Conduct build verification of updated source code versions as agreed under the escrow arrangement.

e) Maintain records of deposit dates, version numbers, and verification status.

2.5 Secure Storage and Information Security

The Service Provider shall ensure:

- Secure storage of deposited materials in offline vaults (Physical Storage) in India.
- Controlled access mechanisms.
- Protection against unauthorized access, alteration, deletion, or disclosure.
- Backup and disaster recovery arrangements.
- Compliance with applicable information security standards and best practices.
- Confidential handling of all deposited materials.

2.6 Escrow Administration

The Service Provider shall:

- Manage escrow account administration throughout the contract period.
- Coordinate communication among Beneficiary and the Depositor/Seller.
- Maintain escrow records and transaction history.
- Issue deposit confirmations and update notifications.

- Facilitate amendment of escrow arrangements whenever required.

2.7 Release Management

The Service Provider shall release the deposited source code & related documentation to BENEFICIARY only upon occurrence of predefined release conditions as specified in the Escrow Agreement.

Illustrative release conditions may include:

- Insolvency, bankruptcy, liquidation, or closure of the Depositor.
- Failure of the Depositor to provide contracted support and maintenance services.
- Material breach of contractual obligations by the Depositor.
- Discontinuation of the software product or support services.
- Any other mutually agreed release event.

The Service Provider shall:

- Verify release requests.
- Follow agreed release procedures.
- Maintain records of release decisions and actions.
- Provide the deposited materials to BENEFICIARY upon valid release authorization.

2.8 Reporting

The Service Provider shall provide:

- Initial Deposit Verification Report.
- Build Verification Report.
- Periodic Update Verification Reports.
- Release Event Reports (if applicable).
- Any other reports requested by BENEFICIARY under the agreement.

3. Service Period

The contract shall remain valid for a period of Three (03) Years from the date of execution of the Escrow Agreement, extendable as per mutual agreement and organizational requirements.

4. Deliverables

The Service Provider shall deliver during the course of the agreement:

1. Executed Escrow Agreement.
2. Escrow Account Setup Confirmation.
3. Initial Deposit Receipt Confirmation.
4. Source Code Verification Report for initial deposit.
5. Build Verification Report for initial deposit.
6. Final Closure Report upon completion/termination of the agreement/Contract.
7. Update Verification Reports and Build Verification Report in case of source code modification updates/retrieval/redeposit as required on actual basis.
8. Release Administration Services in case of release event as per agreement.

5. Payment Terms

1. The charges pertaining to annual physical storage, maintenance of version history, source code verification, and build verification for initial source code deposit shall be payable within 30 days of successful completion of the services, in accordance with the terms and conditions of the contract.
2. The charges arising from source code updates/retrieval/redeposit, including version history updates, source code updates, code verification, and build verification, shall be payable within 30 days of submission and acceptance of the relevant reports, as per the contract provisions and **payment will be released on actual basis after services may available**.

XI) Clarification of Bids/Shortfall Documents:

During the evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be sought only once on GeM portal, asking the bidder to respond by a specified date/period (i.e. seven days). If the bidder does not comply or respond by the date/period (i.e. within seven days), his tender will be liable to be rejected.

Depending on the outcome, such bids are to be ignored or considered further. No post-bid clarification at the initiative of the bidder shall be entertained.

Note: While submitting the Clarification/Shortfall Document any technical difficulty occurs on GeM portal, then the bidder can submit the Clarification / Shortfall Document through e-mail (e-mail id: purchase.isp@spmCIL.com).

The Procuring Entity reserves its right to, but without any obligation to do so, seek any shortfall information/ documents only in case of historical documents that pre-existed at the time of the Bid Opening, and which have not undergone change since then and does not grant any undue advantage to any bidder. As far as the submission of documents is concerned regarding qualification criteria, after submission of the bid, only related shortfall documents shall be asked for and considered.

For example, if the bidder has submitted a supply order without its completion/performance certificate, the certificate will be asked for and considered. However, no new supply order shall be asked for to qualify the bidder.

NOTE 1: Request for extension of the bid opening date and / or any other query related to bid should be made through GeM Portal only, no other means of communication will be entertained.

NOTE 2: Bidders may please note that GeM is capturing and showing the IP addresses used by the bidder(s). The received bids having matching / common IP address with bidder(s), shall be outrightly rejected & shall not be considered for further evaluation. With respect to the representation window for rejected bidders, any clarification/shortfall document submitted in the representation window will not be accepted. Only a representation about the wrong evaluation done will be considered.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
